Abstract (12 pt, bold)

The abstract in this section is in Indonesian. Written using Times New Roman font with font size 10 and single space. Abstract is an overview of a final project that contains background or problems, objectives, research methods, results, and conclusions. Abstract is written in one paragraph and does not exceed 250 words.

Keywords: 3-5 words, alphabetical, separated by signs (;), 10 pt, italicized)

Title in English (12pt, bold, centered)

Abstract (12pt, bold)

Abstract should be written in English. The abstract is written with Times New Roman font size 10, and single spacing. The abstract should summarize the content of the paper, including the aim of the research, research method, and the results, and the conclusions of the paper. It should not contain any references or displayed equations. The abstract should be no more than 250 words.

Keyword: up to 5 keywords in English (10 pt, italics)

Introduction

The introduction is written after the keywords, with three blank spaces and 12 pt font size. The format for writing this article may vary based on the discipline, but in general it still refers to the format mentioned in the provisions above. The content of the introduction section is written concisely, generally consisting of background problems, problems and research objectives. The introduction section mainly contains: (1) research problems; (2) insights and problem-solving plans; (3) formulation of research objectives; (4) summary of theoretical studies related to the problem under study. This section sometimes also contains expectations of the results and benefits of the research. The length of the introduction section is about 2-3 pages.

Methods

The subject matter of this section are: (1) research design; (2) population and sample (research targets); (3) data collection techniques and instrument development; (4) and data

analysis techniques. For research that uses tools and materials, it is necessary to write down the specifications of the tools and materials. Tool specifications describe the sophistication of the tools used while material specifications describe the type of materials used. Inform briefly about the materials and methods used in the research, including the subjects/materials studied, tools used, experimental design or design used, sampling techniques, variables to be measured, data collection techniques, analysis and statistical models used.

Research Results

The content of the research results section is written concisely. Research results can be presented with the support of tables, graphs or images as needed, to clarify the verbal presentation of the results. This section is the main part of the research article and is usually the longest part of an article. The research results presented in this section are "clean" results. Data analysis processes such as statistical calculations and hypothesis testing processes do not need to be presented. Only the results of the analysis and the results of hypothesis testing need to be reported. Tables and graphs can be used to clarify the verbal presentation of research results. Tables and graphs should be commented or discussed. For qualitative research, the results section contains detailed sections in the form of sub-topics directly related to the research focus and categories.

Table (12pt, bold)

If in a discussion there is a format in the form of a table, how to write a table using Times New Roman 10 pt single-spaced letters. Similarly, the title of the table uses Times New Roman 10 pt font with bold and single space. Table numbers use Arabic numerals. The distance between the text and the table title is one space with a font size of 10 pt, the same as the distance between the table title and the table. Meanwhile, the distance after the table to the next text is two spaces with a font size of 10 pt. Each table should be given a short title. Place explanations and abbreviations in the table caption, not in the table title. The maximum number of tables is 6.

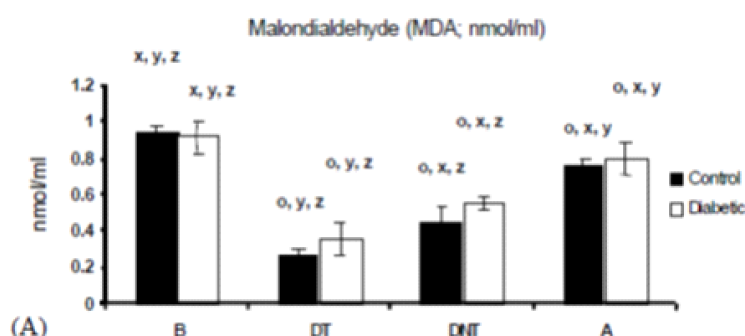

Images (photos, graphs, diagrams) are placed in the center of the page and are spaced one space between the image and the text above it. Image captions are located below the image using a font size of 9 pt in bold. The distance between the image and the caption is one space with a font size of 10 pt. The distance between the image caption and the next text is two spaces with a font size of 10 pt. Here is an example:

If images used are the work of others, the author must have obtained permission to publish from the owner. Photographs of potentially recognizable persons must be accompanied by written permission. Images that have been published must be referenced. Photographs and figures should be numbered consecutively according to their appearance in the text. The maximum number of tables/figures is 6. **It is recommended to use the text box feature in MS Word to insert images or graphics because the results are more stable against format changes and page shifts than inserting images directly.**

Math Formula

Write math equations in Times New Roman font or Symbol font. If there are several equations, number the equations sequentially, putting the rightmost part as (1), (2), and so on. Use signs to make the equation writing more concise. An example is as follows:

$$\beta + \alpha = X \quad (1)$$

Discussion

The content of the discussion section is written concisely, linked to the theory used. The discussion in the article aims to: (1) answer the formulation of the problem and research questions; (2) show how the findings were obtained; (3) interpret the findings; (4) link the research findings to the established knowledge structure; and (5) bring up new theories or modify existing theories. In answering the problem formulation and research questions, the research results must be explicitly concluded. The interpretation of the findings is done using logic and existing theories. Findings in the form of reality in the field are integrated/related to the results of previous research or to existing theories. For this purpose there must be a reference. In generating new theories, old theories can be confirmed or rejected, some may need to modify the theory from the old theory.

Conclusions and Suggestions

The content of the conclusion section is written concisely and must answer the research problem.

Acknowledgments

When necessary, acknowledgments can be given to contributors to the research without writing their titles and to specific parties (research sponsors/grants).

References

- The reference list should be in Vancouver style with a minimum of 15 references.
- Please ensure that every reference cited in the text is also in the reference list (and vice versa).
- Reference numbers should be numbered consecutively with the rest of the text.
- Recent journal references (at least within the last five years) are preferred. Book references within the last ten years are preferred.
- Provide the URL of the referenced article.
- Example References (refer to this example in writing your article references, remove [Internet] and provide the URL for each reference)
- Author names are written with a maximum of 6, then replaced with et al.
- Journal name is written in abbreviated version (abbreviation name without using a full stop after the abbreviation)
- Year is written without the month and date
- The page number is written in a shortened version (for example: 653-659 is written as 653-9).
- DOI is written in the form of an https URL and does not end with a full stop
