

# Terms of service

**If you order a commission, this means you have read, understood, and agreed to my following terms**

## I.General Information

- -You are only purchasing the digital file. Not the printed art.
- -I will send you the full resolution picture and smaller version with my signature to your usage online.
- -I reserve the rights of increasing the price if you want a very high detailed drawing.
- -I reserve the rights of cancelling your order if I don't feel that I can do it or you have been proved troublesome in any way.
- -Do not ask me to draw in a different style. If you commission me it's because you like my work, not because your favorite artist is busy.
- -As an artist, my art is constantly evolving, so there might be slight differences between the samples in my gallery and the illustration you will receive (linearts style, coloring method, composition...). They are very slight changes, but please keep that in mind.
- -I can show you WIP if I feel insecure of how the drawing is looking or you can ask about it, but don't do it everyday.
- -I will work as best as I can, but you're the one who have to make sure that whatever you order is suitable with my style so you can avoid any dissatisfaction in the future. Browse around my gallery for samples as much as you need and please refer to the "Do's and Do Not" section.
- -Don't complain about price, I spend my free time on personal piece only for you.

## II.Copyright/Usage policy

**1. As the artist I hold every right to the produced artwork, so I may do whatever I wish with it, in example;**

- - Post/display the picture anywhere I want (giving you proper credit as the owner of the characters).
- -Promote myself with it in any place.

**2.As a commissioner you may:**

- - Repost the art on other sites with proper credit to my gallery or page (with no profit purposes). I will appreciate if you only repost the small low resolution version of the artwork that I will provide
- - Print the art and even make whatever merchandising you want as long as it's only for your personal use and not for sale.
- -Use it as decoration for your deviantART profile, Facebook avatar, Skype... as long as it's a personal account and you're not making any profit with it.

### **3.You are NOT ALLOWED to:**

- -Change, modify, trace or use my works without my permission.
- - Reproduce the copyrighted artwork commercially (meaning making money of it in any way)
- -Take credit for the art.
- -Remove my watermarks /signatures.

### **III.About backgrounds**

- -Simple background is included in the price of every picture. But it's totally up to you if you want it or not.
- -Simple backgrounds means they are plain color, gradient backgrounds with some textures and/or tiny ornamentations.
- -I can't do complex backgrounds, I just can put more effort and do something more than plain color, such as, forest, landscapes etc, but not architecture. Price doesn't include them.

### **IV.Payment process**

- -I will only accept Paypal payment
- -Prices are in USD (\$); ask about other currency
- **-Paypal fees aren't included! What you see is base price for simple character! i.e no complex markings/composition, species I'm familiar with, SFW etc. Plan your purchase beforehand!**
- -After accepting sketch, I require full payment before I start the artwork.
- -I'll send you invoice. Include your PayPal e-mail in order for better workflow.
- -When you send me payment, use "Good and services" option
- -If payment is not received in 48 hours after I've placed the invoice, you will lose your slot (unless stated otherwise previously).
- -I will add you to my to-do list once payment is cleared and details are given.
- -When your commission is done and changes aren't needed, I mark the transaction in PayPal system as delivered. You can expect email about it.

**For auctions: DO NOT retract yourself or you may be blocked.**

- a) On your first problematic transaction you'll receive a simple verbal warning.
- b)The next time you back down from the auction you'll be blocked and loose any future opportunities to buy art from me.

### **V.Work process**

- -I will try to finish your order ASAP, however please be patient with me and don't rush me if you want good quality art piece.
- -The most you'll have to wait for your commission is 3 months (in the worst case, which is not the usual, but it may happen).

- -I tend to work when I feel most motivated so that your commission is done properly and with best effort! (Don't feel upset if I do other art in between.)
- -I will always inform you if something comes up and there is a delay with the art.
- -You may ask how your commission is going but don't expect WIP's every time.
- -If you need your commission to be made by a certain date (example; the commission is a birthday present for someone) you must state it on the beginning. An extra fee may be charged due to giving your commission priority.

## **VI.Changes**

- -When I send you sketch it's the moment where you can ask about changes. Be sure if everything is correct.  
**My sketches are pretty rough! DO NOT ask for changes like hand/leg/fur looks weird - render it.. Look at the sketch as whole concept not detail in it, I redo and correct everything after.**
- -After payment has been received I will send out **two to three** thumbnail sketch ideas for your commission for you to review. These are to give you a broader range of selection for your commission. Each will have little to no character details and are just meant to be used as a means of choosing posing/scene setting/etc. When you have made the selection that looks best to you, I will begin the primary sketch.
- -Once the picture is finished, I can only do SMALL changes such as color adjustments and/or add tiny details
- **-If your reference/description given to me was unclear to start with, then you are not allowed to do changes without a fee (only 1-2 minor changes allowed) . Make sure to be clear in your order what you aim for.**
- After description is given and I started to work on it - **ANY further change to the main concept will cost additional fee.** Take your time to write down all I need to know ! I'm not gonna constantly change/correct the drawing.

## **VII.Refunds**

- -I can refund 100% of the payment only if I have not started working after accepting the sketch.
- -You may cancel your commission after I started but the refund amount will depend on how much I have completed. I will still send the incomplete art piece over.
- -You have no right to cancel or demand a refund from the artist under any circumstances after payment are received.
- **-If I have completed the piece already, there are ABSOLUTELY NO REFUNDS.**
- -If you file a chargeback against me, your right to everything I have ever made for you will be retracted and I have the right to sell the copyrighted artwork to new buyers. Also note that you will be blocked and you won't be able to purchase anything from me anymore (commissions, adopts...). Your name and info will be publicly posted everywhere for others to watch out.

## **VIII.NSFW**

### **Adult Content**

You must be 18 or older to order adult content. No exceptions. If you order adult content and I find out you are not 18 or older at the time of purchase, **you will be blacklisted.**

You will not be allowed to commission be again in the future.

**By commissioning me for Adult Content you are admitting to be 18 years or older.**

### **Adult Content in Gifts**

**Absolutely under no circumstance will I do adult rated gift art;** the highest rating any gift piece can go without permission is **Mature**. If you would like to commission an adult rated piece for someone as a gift, then you need to make sure that they come and confirm permission to use their character in an adult piece.
