A FINANCE BILL TO BE ENTITLED AN ACT TO ALLOCATE STUDENT GOVERNMENT FUNDS FOR THE PURPOSE OF FUNDING RAFTING CLUB

WHEREAS, Rafting Club requested \$4,999.00 for the purpose of funding rafting trips; and,

WHEREAS, their expenses will occur in spring 2023; and,

WHEREAS, to be eligible for a Finance Committee Grant, student organizations must complete all of the following requirements¹:

- 1. Be a Registered Student Organization (RSO) with Student Leadership and Engagement.
- 2. Not discriminate on the basis of of race, color, religion (including belief and non-belief), sex (including, but not limited to: pregnancy, childbirth, or a related medical condition, parenting, and sexual harassment), sexual orientation, actual or perceived gender identity, age, national origin, disability, veteran status, or genetic information.
- 3. Have an active bank account before Check Distribution begins.
- 4. Not be on the Ineligibility List.
- 5. Is a connected supplier or is in the process of registering as a supplier.
- 6. Submit a correct and accurate budget using the Finance Committee Grant Budget Tool.
- 7. Submitted a Grant Request via the correct online form.
- 8. Have at least one (1) representative attend a meeting of the Finance Committee to present their Grant Request.

- **WHEREAS**, the Student Body Treasurer along with Student Leadership and Engagement verified Registered Student Organization (RSO) status for the organization; and,
- **WHEREAS**, the Student Body Treasurer verified Ineligibility List status for the organization; and.
- **WHEREAS**, the Student Body Treasurer and Chair of the Finance Committee verified submitted budgets for compliance with Student Government policies and usage of the Budget Tool; and,
- **WHEREAS**, the Student Body Treasurer and Chair of the Finance Committee verified submitted Grant Requests; and,
- **WHEREAS**, the student organization attended the Finance Committee meeting on Wednesday, October 19, 2022 and presented their Grant Request; and,
- **WHEREAS**, the 102st Session Finance Committee voted 6-0-0 to fund the organization up to \$2,000.00 to be used for the first spring rafting trip, and,
- **NOW, THEREFORE BE IT ENACTED**, by the North Carolina State University Student Senate that the following allocation is made to the respective student organization from the Line Item 101 Finance Committee Disbursements:

; and be it further,

- **ENACTED**, receipts must be submitted to the Student Body Treasurer by May 1, 2023 at 11:59 PM ET in order for the student organization to be eligible to receive the reimbursement; and be it further,
- **ENACTED**, if receipts are not submitted by the above deadline, the reimbursement shall be canceled; and be it further,
- **ENACTED**, that the student organization will abide by the Line Item Description to be eligible to receive this reimbursement; and be it further,

- **ENACTED**, the Student Body Treasurer shall have the sole jurisdiction to allow changes to the Line Item Description after the passage of the bill given that the new description falls within the historically allowed expenses from Student Government; and be it further,
- **ENACTED**, the Student Body Treasurer shall have the sole jurisdiction to amend the Finance Committee Grant Request Number, Student Organization Name, Supplier Name, and Line Item Description after the passage of the bill via Treasury Branch Notice; and be it further,
- **ENACTED**, the Student Body Treasurer shall have the sole jurisdiction to allow extensions to the deadline to submit receipts for reimbursement; and be it further,
- **ENACTED**, the receipts submitted shall meet the spending guidelines of NC State University Student Government, North Carolina State University, University of North Carolina System, and the State of North Carolina in order for the student organization to be eligible to receive the reimbursement; and be it further,

ENACTED, this bill shall become effective upon its enrollment.
