- Payment is upfront and done through invoice on PayPal
- I will send WIPs during the process for feedback or any changes you may want
- If you're not sure about something, please feel free to ask me!
- The piece will most likely be finished within a month of payment
 - If I think it will take longer, or there is an unexpected delay, I will update you right away
- No refunds
 - If for some reason I can't complete the piece, then I will inform you and provide a partial refund if the work done up to that point was accepted. If no work was done, then you will receive a full refund

EXTRA COST

- Complex character designs
 - Price will vary depending on the complexity. For example, mechs, detailed weapons, complex armour, and intricate patterns will cost more

 - I may provide multiple versions during the WIP stage for you to choose from, but if you'd like a finished piece with multiple versions, then that will cost extra
 - E.g. different colour palettes, different backgrounds, different expressions, props etc.
- Complex backgrounds
- Multiple outfits/accessories for character & outfit designs

TOS & COMMERCIAL USE

Commercial use

If the work is for the purpose of commercial use, this must be disclosed before payment. Commercial use requires an added 20 EUR per image. **My art may not be used for NFT or any blockchain purposes.**

Credit

I will be credited as the artist or designer for the piece wherever it is posted or shared. Clients may not claim work as their own or anyone else's and therefore must credit me as the artist using my social tag/username/link.

Feedback and revisions

There may be up to 3 major revisions for each WIP shown during the process, not including corrections for mistakes e.g. a missing accessory. Further changes after the 3 major revisions may cost more. Examples of major changes are completely different poses, change in background location, etc.

Clients agree to provide all required art, references, information and assets before work starts and during the process. Otherwise, this can affect the timeline.

Revision later in the process, e.g. after line art, can only be minor. I will actively reach out for feedback throughout the process.

Copyright & Usage

I retain original copyright and ownership of the work, which includes but may not be limited to redistributing, reproducing, advertising, displaying the work in my websites, social media and portfolios according to my discretion. I have rights to repurpose unused process work for future projects, personal or otherwise.

The process will likely be posted on social media, unless the client requests otherwise before the project begins.

Clients are granted exclusive rights for personal use of the Work produced as agreed upon, which must not be transferred to any other parties. Personal use includes:

- social media profile pictures
- signatures
- wallpapers

- personal website display
- social media posts
- physical prints and products

that is not for sale or distribution to any other party.

Unless specified in the commission information or otherwise discussed and agreed upon, commercial licences and reselling rights are not included. **Commercial means usage on streams, broadcast content, or any monetized work.**

This includes but is not exclusive to

- merchandise
- monetized videos
- music releases

Reselling rights means selling the work to another party or another platform.

Agreement

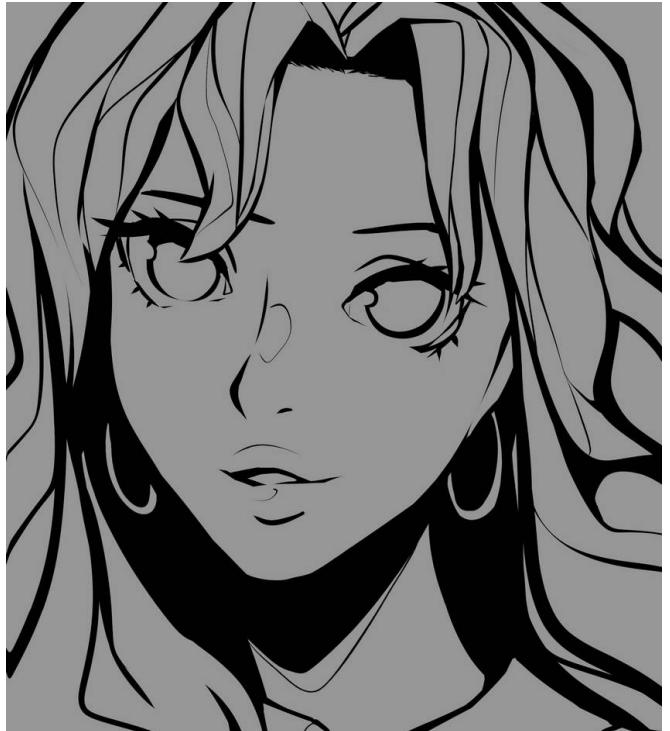
I reserve the right to refuse to accept projects.

By commissioning, **you confirm you are at least 18 and above or have a legal parent/guardian to agree to all of the terms of service as listed above.**

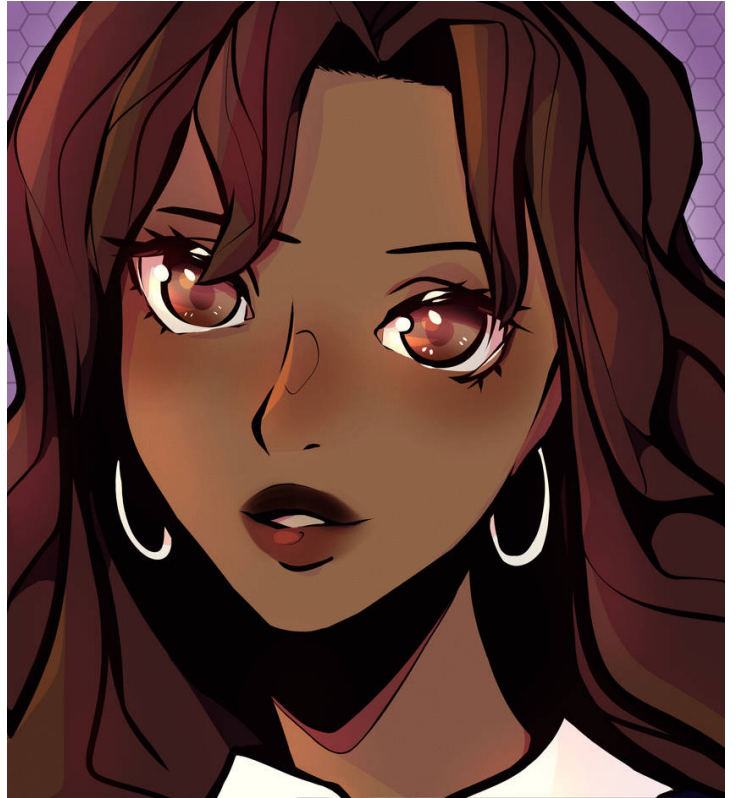
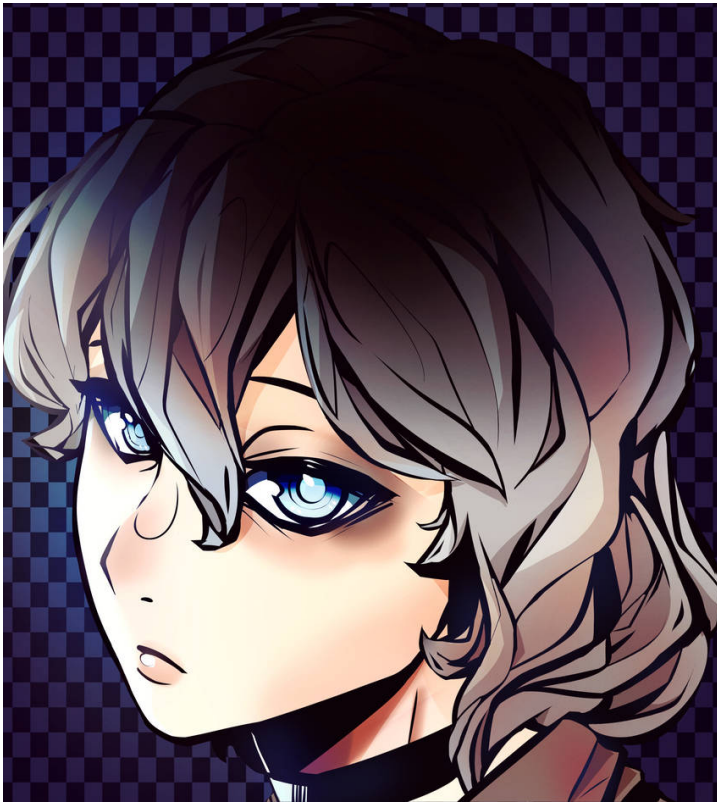

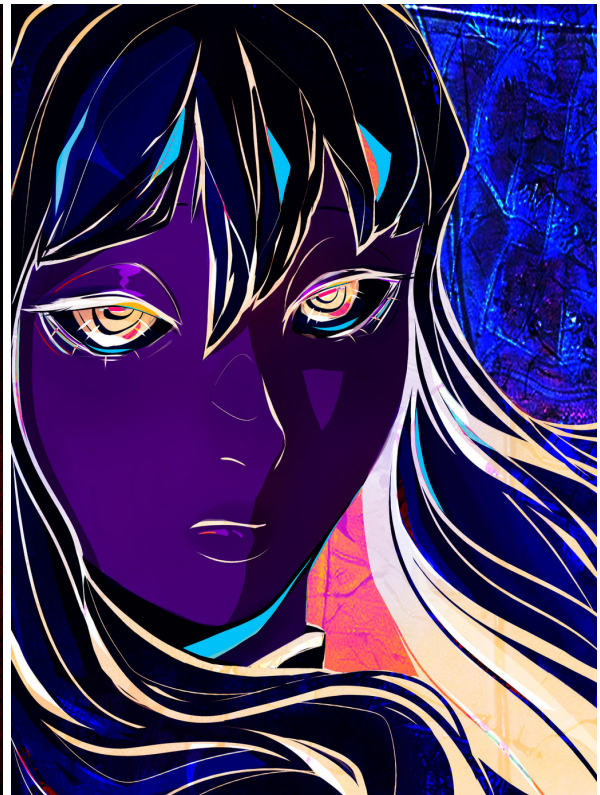

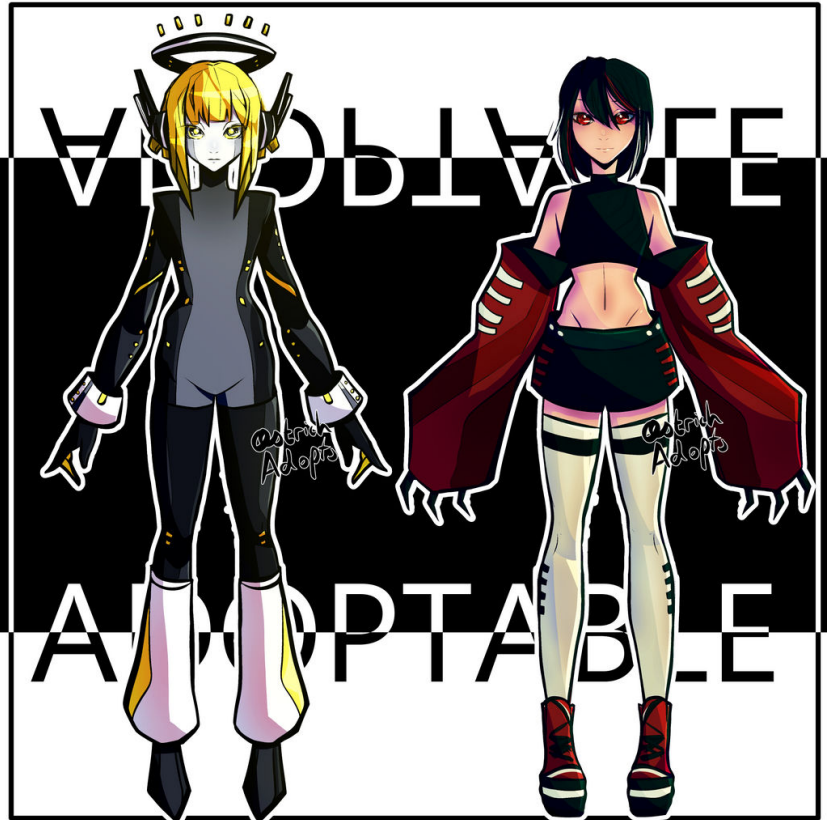
