*Brief Description*: Most lawyers expect appellate courts to defer to the trial court's fact-finding and to focus appellate review on issues of law (or mixed question of law and fact). But appellate courts are routinely required to assess the record in a way that mirrors traditional fact-finding—as (for example) when assessing whether error is harmless or prejudicial. And occasionally (as, for example, when assessing mootness) an appellate court looks at material outside the trial-court record. This session will focus on the contours of "fact-finding" on appeal and will engage with strategies to navigate it.
