

Maker's Market Vendors Agreement

1. By signing and paying the booth fee, you accept and will follow the rules of this contract available online and in print. Fees are \$10 per booth per day.
2. A contract **MUST** be filled out and signed by the person or persons operating the booth during Market hours. Contracts and payment (payable by cash or check to the Future Forge) may be dropped off at the office of the Future Forge, 307 E College Avenue, Silver City, NM 88061 or at the Makers Market on the morning of.
3. The Eligibility and Requirements set out in the Market Rules must be followed.
 - a. Sellers must provide their own tent, tables and displays.
 - b. Seller is responsible for collecting any applicable sales tax.
4. Booth Assignments; Booths will be assigned in the order of contact. Consideration will be given to the type of products you are exhibiting.
