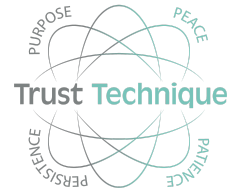

- ▶ To provide practitioners with good guidelines for operating as public practitioners.

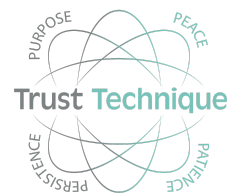
