

# **Startup Land at National Chung Cheng University**

## **Personal Data Collection, Processing, and Utilization**

### **Consent Form**

Startup Land at National Chung Cheng University (hereinafter referred to as “the Land”) collects, processes, and utilizes your personal data in accordance with the Personal Data Protection Act. Please read the following information carefully and provide your consent.

#### **1、 Purpose and Categories of Personal Data Collection**

- (1) The Land collects your personal data for business execution and to conduct ongoing government policy promotion or activities.**
- (2) The categories of personal data collected by the Land include, but are not limited to, your name, date of birth, address, national ID number, gender, educational background, work experience, account information, household registration data, contact address, home phone number, mobile phone number, email address, employer, and other related information that may directly or indirectly identify you.**

#### **2、 Processing or Utilization of Personal Data**

The Land collects, processes, and utilizes your personal data in accordance with the Personal Data Protection Act and relevant regulations, following the Base's [Privacy Policy Statement].

#### **3、 The Land will utilize your personal data in the Republic of China (Taiwan) for a period of 10 years starting from today, using methods such as written, electronic, internet, or other appropriate means. Please ensure that you provide complete and accurate**

**personal data. Failure to provide your personal data or providing incomplete or incorrect information may affect your related rights. You may exercise your rights under Article 3 of the Personal Data Protection Act as follows.**

- (1) Request to inquire or view your data, and request copies, for which the Base may charge necessary costs.
- (2) Request to supplement or correct your data.
- (3) Request to cease the collection, processing, or utilization of your personal data, or request the deletion of your personal data, except where necessary for the Base to perform its duties or business.
- (4) To exercise your rights, you may visit the Base in person or have an authorized representative submit a power of attorney.
- (5) If exercising the above rights affects your interests, the Base will not be liable for any related compensation. If you have any questions regarding the above matters, please refer to the contact information for personal data protection in the Base's [Privacy Policy Statement] to get in touch with the Land.

#### **4、 Other Matters**

**By checking the consent box and signing this consent form, you indicate that you have read, understood, and agreed to all the contents of this consent form, and that you consent to the Base retaining this consent form for future reference. If the person giving consent is a minor (for example, an unmarried person under 18), their legal representative must also sign or stamp this consent form to indicate approval, unless the**

**consent is purely for legal benefits or is necessary for daily life due to their age and status.**

#### **5、 Governing Law and Jurisdiction**

The interpretation and application of this consent form, as well as any disputes related to it, shall be governed by the laws of the Republic of China, with the **Chiayi District Court in**

Taiwan as the court of first instance.
