Why do we process your personal data?

The purpose of the processing is to help students find accommodation during their period of study at the University of Deusto. To this end, those interested in offering their accommodation must consent to providing their personal details so that their accommodation option can be included on the platform to manage student accommodation at the University of Deusto.

What is the lawful basis for processing your personal data?

The legal basis for the processing of your data is the legal relationship established between the persons concerned and the University of Deusto, which provides the service through an external platform responsible for the provision of the service, in accordance with article 6.1.b) of the General Data Protection Regulation.

Who will be the recipients of your personal data?

The processing of your request does not involve the transfer of data to third parties, except in legally binding cases. Nor does it involve the international transfer of such data.

How long is my information kept?

Data will be kept for the duration of the service provided, after which they will be blocked during the statutory limitation period to take legal actions.

What are your rights when you provide your personal data to us?

Any person will have the right to obtain from the University of Deusto confirmation as to whether or not personal data concerning him or her are being processed.

Those concerned have the right to request access to their personal data and rectification of inaccurate data or, where that is the case, request erasure of personal data when, among other reasons, the data are no longer necessary for the purposes they were collected for.

In some circumstances, those concerned may request restriction of processing of personal data, in which case these will only be stored for the exercise or defence of legal claims.

In certain circumstances or for reasons related to a specific situation, those concerned may object to the processing of their personal data. In this case, The University of Deusto will no longer process the data, unless the centre responsible demonstrates compelling legitimate grounds for the processing, or for the exercise or defence of legal claims.

Those concerned may request data portability to receive personal data concerning them which have been provided to the University of Deusto in a structured, commonly used, machine-readable format, to be downloaded by them, or transmitted directly from the University of Deusto to another entity.
