#### F. End of Year Processes for EdReflect

- a. The release date from BloomBoard is March, but still awaiting an official schedule. Kelly McLaughlin will provide a training webinar for Organizational Administrators (district level) and Administrators (building). DESE will advertise many times over and record. DESE will also provide optional follow-up webinars for Beginning Administrators in April.
- b. DESE has been asked about needing summative ratings completed now in order to meet April 1 contract deadlines. A final rating can be calculated manually if needed for an individual teacher.
  - i. Example:
    - Total components = 22
    - Ineffective = 1 point per rating
    - Progressing = 2 points per rating
    - Effective = 3 points per ratings
    - Highly Effective = 4 points per rating
    - Teacher received the following summative component ratings:
       Ineffective: 0 Progressing: 6 Effective: 14 Highly Effective 2
    - Teacher Total = 62 points
    - 62/22 = 2.81 rating



# Literacy

#### K-5 Literacy

They have also been supporting administrators and instructional leaders with their classroom walkthroughs to practice using the "Look For" documents as well as the Smart Card for SOR evaluations. Cindy and Madison are **not** the evaluators in this process, but can offer insight into what instructional practices should be observed based on the components of the documents.

#### **Technical Support**

The DESE ESOL Specialist Team has determined districts in the greatest need for technical assistance using a risk assessment. This data will inform our targeted work with districts in our cooperative areas.

## **EL Achieve's Spring Symposium**

Our grant with DESE is providing registration fees for districts who have partnered with us or who have participated in EL Achieve's Institutes on their own. This year's symposia will be virtual. There are two options, one in April and one in May.

#### Symposia Goals

- Learn alongside our colleagues by sharing experiences and accomplishments with the E.L. Achieve community
- Deepen learning to improve instruction and build resilient systems of support for English learner students
- Reflect on implementation of Systematic ELD and/or Constructing Meaning to strategically respond to current needs

#### **State Initiatives**

- Systematic English Language Development (SysELD): we are wrapping up our third year of partnering with DESE and EL Achieve (<a href="http://www.elachieve.org/">http://www.elachieve.org/</a>) to provide quality dedicated English instruction to language learners statewide. At this point, there are 27 districts being impacted by this partnership in the following co-op areas:
  - Crowley's Ridge 2
  - o Dawson 4
  - o Guy Fenter 1
  - o Northeast 1
  - Northwest 9
  - o Pulaski County 1
  - o Wilbur D. Mills 9

Members of the ESOL Team have successfully completed an apprenticeship with the company and are now certified presenters for the state. We have worked closely with EL Achieve in developing professional development virtually for this school year for both ELD teachers and district/building administrators; we started our latest cohort in early



September 2020 and finished the 5-day teacher institute in December 2020. Administrator training will be completed in February 2021 with coaching/mentoring sessions scheduled as needed.

The EL Unit has met with several other district coordinators in recent months to provide more information about joining our partnership. *If your district is interested in learning more about this initiative, please contact Lisa Coats.* 

• Intention Planning Practice (IPP): we are completing our 3rd year in partnering with DESE and Education Northwest (<a href="https://educationnorthwest.org/">https://educationnorthwest.org/</a>) to provide area districts in this program to insure that English Learners are being supported in the content areas. This model includes professional development for teachers/instructional leaders as well as on-site coaching visits with follow-up and planning. All ESOL Specialists are collaborating to provide professional development to educators from the Northeast and Dawson cooperatives. The team will be sharing information at district coordinator meetings to plan for the 2021-2022 school year.

# **Migrant**

- The NWAESC MEP has tentatively scheduled a Migrant Student Advisory Council (MSAC) meeting for March 16th at 9:30 am and 1:30 pm. This virtual council meeting will involve information from the personnel at Drury University.
- We are currently making plans for our MEP summer school sessions. We conduct a short summer school through our program to help mitigate the effects of summer loss, possibly help with credit recovery (as needed and allowed), and to help with statistical data which could increase the MEP funding for future years. At the time of this writing, it is unknown if NWAESC Summer School will be conducted in face-to-face sessions or via online sessions. We hope to have that information solidified by next month.
- We are preparing for a Parent Advisory Committee (PAC) meeting in the month of March. This committee will help us improve our program. We hope to have a date set soon.
- The state MEP will have a parent meeting on March 9th. This meeting will be conducted over Zoom and will discuss a data system that can help parents when they transition from one school to the next.
- We are sponsoring a Reading Challenge for the MEP students in our region. The challenge ends on March 3rd and prizes will be awarded on that date. There will be more data released at the next update regarding the successes of this Reading Challenge.
