This milestone reflects our unwavering commitment to embedding open government principles as a means to improve public service delivery and strengthen citizen trust.

4.1. What is the long-term vision for open government in your context and jurisdiction?

Our long-term vision is to have a Kaduna South LGA where governance is fully transparent, accountable, participatory, and equitable fostering trust between citizens and government through the use of open governance tools. Our core focus is to improve access to quality healthcare services. This will be achieved by providing more health centers, providing essential medical equipment, advocate for recruitment of more health personnel and the engagement of support staff, strengthening healthcare services through monitoring and supervision of primary healthcare centers all of which are priorities our Action Plan intends to implement. We also envision a model LGA where vulnerable groups, including women, youth, and persons with disabilities play a leading role in decision-making. This vision aligns with Kaduna State’s SUSTAIN Agenda, the State Development Plan, and the Sector Implementation Plan, all aimed at building a united and prosperous state.

4.2. What are the achievements in open government to date (for example, recent open government reforms)?

Kaduna South LGA has made significant strides in advancing open governance, building on Kaduna State’s broader reform agenda. In 2025, Kaduna South LGA became the first Local Government Area in the state to formally join the Open Government Partnership (OGP) at the national level, a milestone that reflects our commitment to transparency, accountability, and citizen participation. To support this milestone, the OGP Multi-Stakeholder Steering Committee was formally inaugurated by the States Government Co-Chair.

Key Achievements to Date:

- a. Participatory Town Hall Meeting on Health held to identify gaps and gather citizen feedback for improved healthcare.
- b. Participatory Budget Town Hall Meeting for the 2026 Budget, involving citizens in priority setting through community consultations.



- c. Launch of a Toll-Free Healthcare Feedback Line for residents to report issues at Primary Health Centers (PHCs).
- d. Quarterly Business Meetings with the LGA Chairman overseeing performance reviews of PHCs.
- e. Enrolled 1,000 individuals into the Kaduna State Contributory Health Management Authority (KADCHMA).
- f. Provision of Delivery Kits to pregnant women to support safe deliveries in PHCs.
- g. Nutrition Support distributed Ready-to-Use Therapeutic Food (RUTF) to malnourished children.
- h. Health Workforce Strengthening with deployment of doctors, pharmacists, medical lab scientists, midwives, and nurses.
- i. Established a taskforce for monitoring health services.
- j. Strengthened Ward Development Committees (WDCs) as grassroots accountability platforms.
- k. Introduced stipends for community volunteers to sustain motivation and health interventions.

4.3. What are the current challenges/areas for improvement in open government that the jurisdiction wishes to tackle?

Despite notable achievements in improving healthcare access and services in Kaduna South, the health sector continues to face significant challenges that hinder its overall effectiveness. These persistent issues affect the quality and delivery of healthcare, limiting the ability to meet the growing needs of the population. *Kaduna South faces challenges around the Health Sector as follows:*

- a. Limited Funding hindering the Supply of Adequate Equipment and Drugs
- b. Insufficient training and retraining opportunities for healthcare personnel, continuous professional development is crucial for maintaining high standards of healthcare delivery.
- c. There is a critical shortage of healthcare workers, causing overwork, burnout, and lower quality of patient care.
- d. Healthcare workers in Kaduna South often receive inadequate welfare and incentives, including low salaries, poor working conditions, and lack of benefits.
- e. Inadequate availability of ambulances, that leads to delays in reaching health facilities during critical emergencies.
- f. Insufficient supportive supervision of health service delivery.



4.4. What are the medium-term open government goals that the government wants to achieve?

Over the next few years, we want to build an ecosystem of trust, efficiency, and equity. Specifically;

- a. To increase the coverage of routine immunization programs, ensuring broader protection against preventable diseases.*
- b. To reduce maternal and child mortality rates through improved healthcare interventions and services.*
- c. To expand healthcare delivery coverage, making services more inclusive and accessible to all segments of the population.*
- d. To enhance the availability and distribution of healthcare delivery kits to support effective medical care.*
- e. To reduce the spread of communicable diseases through strengthened prevention and control measures.*
- f. To address malnutrition issues by implementing targeted nutrition programs and support systems.*
- g. To increase the supply of essential drugs across all health facilities, ensuring consistent availability.*
- h. To boost enrolment of individuals into the health insurance scheme, improving financial access to healthcare services.*

By monitoring progress via the Steering Committee and publishing reports, the plan fosters long-term accountability, directly advancing a transparent, inclusive Kaduna South where citizens co-own governance.

The LGA has also held different townhall meetings to provide a platform to inform residents and for voices and opinions to be included in policy making. 1. **Inadequate Access to Quality Health Care-** Many communities within Kaduna South Local Government have inadequate staffing, equipment, and infrastructure.
2. **Weak Health Supply Chain Management-** Frequent stockouts of essential health supplies due to weak procurement and distribution systems.
3. **Weak Data Management Systems-** Health records are often paper-based, leading to inefficiencies in patient tracking and reporting.
4. **Insufficient Monitoring and Evaluation of PHCs-** There's no financial support to facilitate M & E processes for assessing PHC performance and reporting.
5. **Low Community Engagement in Health Planning-** Citizens are inadequately involved in setting health priorities or evaluating service delivery.
6. **Limited Capacity of Health Workers-** Many health workers within the LGA lack training in open data practices, citizen engagement, and digital tools that will sufficiently drive service delivery. The weak capacity has also been seen in Local Government health workers attitude towards service delivery.

7. Status quo

The situation analysis in the LGA around healthcare service delivery has revealed significant challenges that have hindered the effective provision of services. Limited funding severely restricts the procurement and availability of essential medical equipment and pharmaceuticals. Additionally, a shortage of medical personnel in the LGA leads to increased workloads, burnout, and a decline in the quality of patient care. While these issues persist, healthcare workers face inadequate welfare and incentive packages. Furthermore, the limited availability of ambulances in Kaduna South severely restricts emergency medical response and patient transport services. In addition, insufficient supportive supervision and monitoring within the LGA hinder the effective delivery of healthcare services. Despite these challenges, the health sector has received significant attention from the leadership of the LGA in several key areas: increased investment in health supplies, fostering strong partnerships for facility upgrades, and the introduction of policy reforms to enhance citizen engagement, including the establishment of a toll-free line.
