

SOCK'S TERMS OF SERVICE

GENERAL TERMS OF SERVICE:

1. My work is **PURELY** for **PERSONAL USE**
 - Unless directly discussed, you are not allowed to commercially use my work
 - **DO NOT** feed my work to AI, breach of this results in an instant blacklist
2. **NO REFUNDS** only **MINIMAL EXCEPTIONS**
 - Unable to meet a deadline can result in a **PARTIAL** refund
 - Unable to complete the artwork can result in a **PARTIAL or FULL** refund
3. I have the **RIGHT to REFUSE** commissions
 - Commissions i am unable to accomplish or are not comfortable doing fall under this
4. **PRICES MAY VARY IN TERMS OF COMPLEXITY**
 - This includes design complexity or overall piece complexity
5. **TURN AROUND TIMES VARY**
 - Please do not expect a fast nor slow turnaround time as they wildly vary with me
 - Please do discuss a deadline with me to receive your piece at a faster and expected time
6. **PRICES CHANGE WHEN THERE IS IMPROVEMENT IN MY WORK**
 - If you have discussed a commission with me prior to the price change, the **final** cost of your commission will **not** be affected
7. Once it's yours, **DO AS YOU WISH**
 - It's your artwork! Feel free to do whatever you'd like with it as long as it follows the terms above

CUSTOM DESIGN TERMS OF SERVICE:

1. **DO NOT** resell my designs for a higher price listing
 - Exceptions are as followed: changed the design whether minimally or not, have added onto the design (e.g. artworks, edits)
2. My designs are **PURELY for PERSONAL USE**
 - Unless directly discussed, you are not allowed to commercially use my work
 - **DO NOT** feed my work to AI, breach of this results in an instant blacklist
3. Once it's yours, **DO AS YOU WISH**
 - It's your character! Feel free to do whatever you'd like with it as long as it follows the terms above

PAYMENT:

1. **PAYPAL ONLY (USD)**
 - With the exception of options offered within other services (Ko-Fi, Vgen etc)
2. **PAYMENT PLANS**
 - **FULL PAYMENT**: receive updates and the final artwork without any watermarks
 - **SPLIT PAYMENT**: receive updates and the final artwork with watermarks until payment is complete.
3. **YOU MUST ALWAYS PAY BEFORE THE SKETCH. NO EXCEPTIONS.**
 - Due to scams, I will no longer take payments after the sketch. You must also be prepared to pay the amount due or I will not work with you.

Deciding to commission me automatically means to agree to my terms of service!
Breaching these terms can result in a blacklist from commissioning me ever again.
