Every paragraph should be single-spaced with indentation in each paragraph. This section also elaborate the literature reviews/theoretical construct of the research. You should tell readers the kinds of research, journal articles and books you use in analysing your data.

#### *Research Involving Human Subjects*

As a minimum, a statement of an ethical statement reads as follows: **"All subjects gave their informed consent for inclusion before they participated in the study."** For non-interventional studies, for example, surveys, questionnaires, and social media research, all participants must be fully informed if the anonymity is assured. As with all research involving humans, ethical approval from an appropriate ethics committee must be obtained prior to conducting the study. If ethical approval is not required, authors must either provide an exemption from the ethics committee or are encouraged to cite the local or national legislation that indicates ethics approval is not required for this type of study. If the study reports research involving vulnerable groups, an additional check may be performed. The submitted manuscript will be scrutinized by the editorial office and upon request, documentary evidence should be supplied.

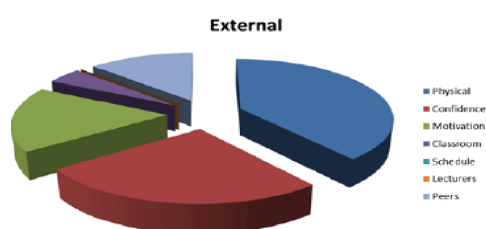


Figure 1. External problems faced by the students
