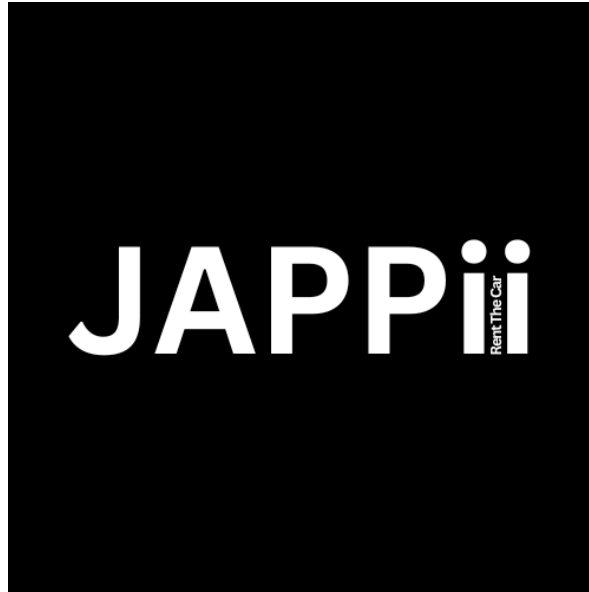

JAPPii Gig Worker Vehicle Rental Agreement

Purpose of Rental

The vehicle provided under this program is intended solely for approved gig-work and delivery-related activities, including DoorDash, Uber Eats, Grubhub, and other approved delivery platforms disclosed to JAPPii. The vehicle may not be used for passenger transportation services, including Uber, Lyft, taxi, or rideshare services.

Nature of Relationship

JAPPii is solely a vehicle rental provider and is not an employer, insurance company, or affiliate of any gig-work platform. JAPPii has no interest in the Guest's earnings, wages, tips, or gig income.

Insurance Responsibility

The Guest acknowledges that JAPPii's insurance does not automatically extend coverage to the Guest's personal liability or gig-work operations. The Guest agrees to maintain valid insurance coverage or purchase appropriate insurance during the rental period. The Guest is solely responsible for understanding the insurance coverage provided by the gig-work platform they operate under.

Liability and Indemnification

The Guest assumes full responsibility for the vehicle from the moment possession is transferred until the vehicle is returned. JAPP II shall not be liable for injuries, death, property damage, third-party claims, or losses arising from the Guest's operation of the vehicle. The Guest agrees to indemnify and hold harmless JAPP II from all claims and liabilities related to the vehicle's use.

Deductible and Damage Responsibility

The Guest agrees to a damage responsibility deductible of up to \$2,000 per incident. If repair costs exceed \$2,000, JAPP II may cover the remaining balance at its discretion or through applicable coverage. The Guest remains fully responsible for minor damages below the deductible amount.

Tolls, Tickets, and Violations

The Guest is solely responsible for tolls, parking tickets, traffic violations, tow fees, impound fees, and all penalties incurred during the rental period.

Maintenance and Mechanical Issues

JAPP II is responsible for oil changes and standard mechanical repairs excluding tire-related damages. The Guest is responsible for tire punctures, nail damage, excessive tire wear, and negligent damage. JAPP II may request odometer readings and require the Guest to return the vehicle for servicing.

Repairs and Modifications

The Guest may not perform repairs or modifications to the vehicle without prior written approval from JAPP II.

Extensions and Return of Vehicle

Guests seeking an extension must contact JAPP II by phone or text for approval. JAPP II reserves the right to require immediate return of the vehicle. Failure to return the vehicle may result in repossession, legal action, and additional charges.

Law Enforcement and Investigations

JAPP II reserves the right to cooperate with law enforcement and provide Guest information where required by law or where unlawful activity is suspected.

Personal Use Restriction

The Guest understands that gig platform insurance may only apply during active work periods and that personal use may not be covered unless the Guest has obtained separate insurance coverage.

Unlimited Miles Program

This program may include unlimited mileage benefits as part of JAPP II's gig-worker rental offering. JAPP II reserves the right to investigate excessive or abusive vehicle usage.

Default and Termination

JAPPII may terminate this Agreement immediately for violations of this Agreement, lack of insurance, fraudulent activity, delinquent payments, unauthorized use, or misuse of the vehicle.

Acknowledgement

By signing below, the Guest confirms that they have read and understood this Agreement, understand the insurance limitations and responsibilities, and voluntarily agree to all JAPPII rental terms and conditions.
