Yes, the writer has avoided general points that are not supported, so that the responses are allocated. The responses were classified separately. A space was allocated to discuss learners of both sexes, as well as teachers and experts. With mentioning the field of study of the respondents.

Yes, the objectivity was clear in this article. The writer left the space for previous studies in presenting the facts and used the questionnaire and the responses of the respondents to appear in the summary and results

This article was written by Dr. Sana Ashour. It was published in 2020 to examine the reverse gender divide in the United Arab Emirates to identify the social, cultural and familial factors underlying this phenomenon. Analysing data drawn from a total of 292 undergraduates and 18 experts using questionnaires. Studies have shown that the educational choices of both sexes are influenced by many logical and social factors such as social beliefs, family and peers. For example, the family gives space,

freedom, and time for males to explore external experiences. This reduces their focus on academic education ,while limiting females' freedom inside the house increases her desire to look to the future and to higher studies. As well as the educational environment surrounding males, which follows the traditional method, which is suitable for females due to their calm and patient nature. Things are different for males, with their dynamic nature, which needs a variety of methods of education. The responsibility lies not only with the family and the school in reducing the gender gap in education, but also with decision makers who encourage males not to care about education by offering high-paid jobs without an educational qualification. The article recommend the future research will examine how the causes of the gender gap can be mitigated through social change and institutional interventions.
