**ON THE QUESTION:** Mayor Hogan noted this was a re-bid of an earlier project. The original bids were rejected because the apparent low bid seemed too low to adequately cover the entire project. This new bid is verifiable, the mayor said.

- An item previously scheduled for discussion the lining of concrete tanks at the Water Filter Plant – was not necessary because a discussion took place earlier this date with LaBella Associates engineers and Superintendent David Oakes, Mayor Hogan said.
- Mayor Hogan said he and Superintendent Oakes have held preliminary
  discussions on the purchase of a new street sweeper for the City of Hornell.
  The current sweeper, which is about seven years old, needs continuous
  maintenance, and Superintendent Oakes said it now needs a rear motor before
  it will operate again. The mayor said the city is now looking to acquire a new
  machine under a lease-purchase agreement that will not affect the city's debt
  service.
- Superintendent Oakes said the city has acquired its tub grinder for use at the new compost pile/brush disposal site. The new site will be open under certain hours, and will be staffed, he said, and a public-education program on how to

use the new site will be implemented. Mayor Hogan said a fee schedule will be set up to allow non-city residents to use the site.
