350 the safe upper limit of CO_2 in the atmosphere. To preserve a livable planet we must reduce the amount of CO_2 from its current level of 400 parts per million to below 350ppm. 350.org

AB 32 CA Global Warming Solutions Act is a law requiring a reduction of greenhouse gas (GHG) emissions.

AB 805 County of San Diego: Transportation Agencies. Made changes to the governance and financing authority of the San Diego Association of Governments, the San Diego Metropolitan Transit System, and the North County Transit District.

Adaptation is the ability to adjust to, or minimize, the potential impacts of climate change or other environmental disturbances.

ARB Air Resources Board Agency in charge of setting air quality and air pollution standards for the state <u>arb.ca.gov</u>

Baseline Emissions is the amount of GHG emissions released in a designated year against which future changes in emissions levels are measured.

<u>Business as Usual</u> (BAU) is a scenario used for the projection of GHG emissions at a future date based on current technologies and regulatory requirements in absence of other reductions.

<u>CalEnviroScreen</u> Screening methodology used to help identify CA communities that are disproportionately burdened by multiple sources of pollution. Pursuant to SB 535.

CAP Climate Action Plan US State Climate Action Plans

CAPTI Climate Action Plan for Transportation Infrastructure CalSTA adopted CAPTI in 2021, which details how the state recommends investing billions of discretionary transportation dollars annually to aggressively combat and adapt to climate change while supporting public health, safety and equity. CAPTI builds on executive orders targeted at reducing GHGe in transportation, which account for >40% of all emissions, to reach the state's ambitious climate goals.

CARB California Air Resources Board

CCA Community Choice Aggregation - state policy enables local government entities to offer clean, local energy at competitive rates while maintaining the existing electricity provider for transmission and distribution services.

CCE community choice energy - see CCA

CCS Carbon Capture and Storage/Sequestration - Capture of carbon dioxide (CO2) at emission sources, transporting and then storing or burying it in a suitable deep, underground location.

CEQA California Environmental Quality Act is a state law requiring state and local agencies to assess the environmental impacts of a proposed private or public

EPA Environmental Protection Agency

Executive Order EO-S-3-05 by the Governor of California in 2005, established greenhouse gas emission reduction targets for California: by 2010, reduce GHG emissions to 2000 levels; by 2020, reduce GHG emissions to 1990 levels; by 2050, reduce GHG emissions to 80 percent below 1990 levels. In April of 2015 **EO B-30-15** added the target of 40% below 1990 levels by 2030. **EO B-55-18** Carbon neutrality by 2045. Signed on 9/10/18. <u>EO B-55-18</u>

Fossil Fuel is a general term for combustible geologic deposits of carbon, including coal, oil, natural gas, oil shale, and tar sands. These fuels emit carbon dioxide into the atmosphere when burned.

GHG greenhouse gas; a gas in the atmosphere that absorbs and emits radiation within the thermal infrared range (heat).

GHGe greenhouse gas emissions

Greenhouse effect is the trapping and build-up of heat in the atmosphere (troposphere) near the Earth's surface.

IRA Inflation Reduction Act of 2022 - <u>US Dept of Energy</u>

LCFS The <u>Low Carbon Fuel Standard</u> is designed to decrease the carbon intensity of California's transportation fuel pool and provide an increasing range of low-carbon and renewable alternatives, which reduce petroleum dependency and achieve air quality benefits.

LOSSAN Los Angeles-San Diego-San Luis Obispo rail corridor, 351 miles, is the second busiest intercity rail corridor in the nation

Mitigation is an action to either reduce the amount of GHGs being emitted into the atmosphere or remove previously emitted gases from the atmosphere.

EOR Enhanced Oil Recovery - Injecting depleted oil fields with substances that will force residual oil into the well(s). *U.S. Dept. of Energy*

"Natural Gas" Natural gas is a widely used fossil fuel that is 70-90% methane, a potent greenhouse gas.

NCTD North County Transit District

ppm parts per million; generally used to indicate the ratio of carbon dioxide equivalents in the atmosphere

QOL Coalition Environmental, and social justice groups (Sierra Club, EHC, CAC, SD Coast Keepers, Labor groups, other individuals) which includes SD350 and which meets weekly. It advocates mainly on transportation-related issues. Formed to oppose Measure A in 2016 and group decided to stay together afterwards.

Renewable Energy is energy that comes from natural resources that are replenished on a human timescale.

SB 100 The 100 Percent Clean Energy Act of 2018 SB 100

SB 150 Requires CARB to report to the Legislature starting 2018 and every four years thereafter, to discuss progress made under SB. <u>SB 150</u>

SB 375 Sustainable Communities and Climate Protection Act 2008 supports the State's climate action goals to reduce greenhouse gas emissions through coordinated transportation and land use planning with the goal of more sustainable communities.

SB 535 California Climate Investments to Benefit Disadvantaged Communities

SB 743 (2013) - This law initiated an update to the CEQA Guidelines to change how lead agencies evaluate transportation impacts under CEQA, with the goal of better measuring the actual transportation-related environmental impacts of any given project. SANDAG is in the process of deciding on a strategy: expected June 2026.

SB 1137 (2022) - Landmark drilling bill prohibits the issuance of well permits and the construction and operation of new production facilities within a health protection zone of 3,200 feet from a "sensitive receptor" - <u>CA Dept of Conservation</u>
