IMPORTANT INFO

- I have the right to deny commissions that I don't want to take.
- If at any point the client makes me feel uncomfortable by being rude, aggressive, creepy or sexual towards me, the behavior will be addressed. If the behavior doesn't stop, you will be blocked/blacklisted and your commission will be dropped.
- DO NOT commission me if you are homophobic, transphobic, racist, a pedophile, zoophile, etc, or if you support any of these things. If I am already working on your commission and I find out that you are or support any of these things, you will be blocked/blacklisted and your commission will be dropped without a refund.
- I will not draw anything that makes me uncomfortable.
- DO NOT use commissioned art for NFTs.
- If you want an NSFW commission, your age must be visible in your bio and you MUST be 18+. If I find out you're a minor and have commissioned me for NSFW work, you will be blocked/blacklisted immediately and you will not be refunded.

PAYMENT

- Payment through PayPal only
- All prices in USD. You as the client are responsible for finding out exchange rates and deciding whether you can afford the commission. I won't do that for you.
- The complexity of a character can change the price of a commission
- Reference photos are required
- Any changes in price will be discussed prior to payment.
- I am willing to work out a payment plan if needed for commissions over \$150, however I will not start work on your commission until payment is received in full.

REFUNDS

- Refunds can be discussed and a partial refund may be accepted on a case by case basis. In the case of a personal emergency on the side of the client, or if I determine that I cannot complete a commission for whatever reason, I will offer a refund.
- If for whatever reason, you must ask for a refund, please do so through private messages. We will work something out.
- Absolutely NO refunds on completed work.

PROCESS/WORKFLOW

- I do commissions in the order that I receive them
- Upon commissioning me, you will be placed in a queue and I will work through the queue one by one
- I have the right to work on personal pieces whenever I want. I need to make personal art in order to keep myself from getting burnt out. If I am messaged about this and harassed about making personal art instead of working on your commission, you may be blocked/blacklisted.
- I may take a long time! I'm not a machine, and I can't always be making art. On top of this, because I work off a queue, there will be other clients ahead of you. Unless you've

- given me a specific time frame you need a commission by, please be patient as I get to yours.
- Typically, I will send an update at the end of every stage of the commission.
- Infrequent check-ins are allowed and okay, but do not message me every day asking for an update on your commission. I will block/blacklist you if you continue to do this after being asked to stop, and you will be refunded.

FIXES/CHANGES

- I will make any desired fixes during the rough sketch/sketch phase. As the client, I do
 expect you to let me know if there are things that need to be changed in the early stages
 of the commission.
- Any changes that are requested past these stages and determined "not easily fixable" may change the price of the commission.
- I will not make any changes to the final illustration

RIGHTS/ROYALTIES

- I, as the artist, hold the rights to the finished illustration. This means that I am allowed to use the finished work for the following:
 - Promotion for myself and my art
 - Posting to any sites that I share my work on
 - Examples for commissions
- You, as the client, are allowed to:
 - Use the copyrighted art for personal use only, unless otherwise specified
 - Print the art and claim rights to the character
 - Use the art to promote yourself, <u>as long as you provide proper credit to me, the artist</u>
- If you break these terms in any way and perform Copyright Infringement, every right you had to the drawing will be retracted.
- The following is considered Copyright infringement:
 - Reproducing/using the copyrighted artwork commercially.
 - Taking Credit for the creation of the artwork.
 - Removing any watermarks/signatures.
 - Altering the artwork without my, the artist's, consent.

Upon payment for your commission you automatically agree to every term listed in this document as well as any consequences should you go against them, whether you read the document or not.
