"One-stop location where people affected by the fires can access relief funds, get help with job placement and training, look for temporary employment and apply for small-business loans. They can also access emergency shelter and rental assistance and get help filing taxes at the centers, among other services."

5. FEMA Assistance

For those who lost homes (owners and renters) or were displaced (permanently or temporarily); deadline to submit FEMA claims = March 31!

- o Immigration status does not matter for these kinds of help:
 - Finding people who are lost
 - Emergency shelter, food, and water
 - Transportation
 - Emergency supplies (medicine, clothing, etc.)
 - Crisis counseling and disaster case management
- o There are immigration status requirements for the following forms of long-term assistance from FEMA:
 - Temporary rental housing
 - Help with lodging expenses
 - Repair and replacement of destroyed housing
 - Replacement of lost items
 - Medical and funeral costs
 - Small Business Administration loans
- o People who qualify for these long-term forms of assistance are:
 - o Lawful permanent residents (people who have green cards)
 - o Refugees, people granted asylum, or people granted "withholding of removal/deportation"
 - o People paroled into the U.S. for at least 1 year
 - o Cuban or Haitian entrants
 - o Certain survivors of domestic violence
 - o Trafficking survivors
 - o COFA citizens (Republic of Palau, Micronesia, and Marshall Islands)
- o Mixed status families may be eligible if there is a qualifying person (including minors) in the household. Learn more about how mixed status families can apply for FEMA aid:

Important – There is a line in the FEMA aid application that says that they are allowed to share information with ICE. To our knowledge, FEMA <u>has not</u> shared information with ICE in the past. If you want to talk to an advocate about this, contact NLSLA at 800-433-6251, or another trusted organization.

People should **never provide false information**. This can cause trouble and may affect someone's chance of getting U.S. citizenship or a green card.

--> Supplements to FEMA Assistance

- Small Business Administration (SBA) The SBA can provide disaster assistance for homeowners, renters, nonprofits, and businesses of all sizes. People who are undocumented cannot access assistance through SBA.
 - o <u>Home Disaster Loans</u>: Loans to homeowners or renters to repair or replace damaged real estate and personal property, including cars.
 - Business Physical Disaster Loans: Loans to businesses, nonprofits, and faith-based organizations to repair or replace damaged property, including real estate, inventories, supplies, machinery and equipment.

"California's SSGP, administered by the CDSS' DSB, may provide grant funds to assist people who have suffered damage in a disaster area declared by the President when the federal assistance to Individuals and Household Program (IHP) is implemented. The SSGP is 100 percent State funded. The grant

may assist with any eligible items not already addressed by the IHP. However, individuals must have applied to the Federal Emergency Management Agency (FEMA) and maximized the IHP award in order to be eligible for SSGP. State grants cover disaster-relief needs in the same categories as the IHP.

If you have reached the maximum IHP assistance, FEMA will automatically transmit your application information to SSGP. There is no separate application process for SSGP. If you have questions about the SSGP, you may contact SSGP at 1-800-759-6807, or for the speech- or hearing-impaired, the TTY number is 1-800-952-8349."

6. Tenants' Rights

My unit was impacted by the fires:

- o Do I need to pay rent?
 - If the unit is completely destroyed, no. Your lease will end. You
 no longer have the right to live there and do not have to continue
 paying rent. The landlord must refund unused portions of rent and
 return security deposits.
 - o If the unit is "redtagged", no. You do not have to pay rent while the unit is "redtagged" and you are unable to use the unit. Once a City Inspector declares the unit to be safe for habitation, you have the right to continue occupying the unit and will need to start paying rent to your landlord.
 - If the unit is damaged but is still livable and is not destroyed, yes. If you want to move out, you need to give landlord a 30-day notice of your proposed move out. You will need to pay rent for those 30 days.

Does your apartment have lots of smoke and ash damage and the landlord will not clean/address?

- o Medi-Cal participants displaced by fire to another county can easily transfer case to new county (temporarily or long-term)

- If you are a Medi-Cal recipient who lost prosthetic dental implants, medications, eyeglasses, etc. in the fire, you can get those replaced and covered by Medi-Cal.

9. Food Assistance + County Cash Aid

Food Assistance

 CalFresh - There are immigration status requirements for CalFresh. The following are eligible:

- Naturalized citizens, lawful permanent residents (green card holders), U and T Visa applicants/holders, VAWA self-petitioners, people granted asylum, and refugees (and some others)
- People who are undocumented and DACA + TPS recipients cannot get CalFresh (can get WIC and access food banks, though)
- Mixed status families can get CalFresh for members of the family who have qualifying immigration status (like citizen children).
- Use of CalFresh IS NOT included in the public charge test.

- Replacement CalFresh Benefits (for people who already receive CalFresh)
 - If you lost food as a result of destruction or power outage due to the wildfires starting 1/7/25, you can request 1 month's worth of CalFresh to replace it. Ask for help filling out a CF 303 form <u>Eng</u>. Must apply by 2/5/2025!

CalFresh for Hot Food

 People can use their EBT card to buy hot or prepared food from grocery stores (not restaurants) until 2/8/2025.

Disaster CalFresh

- Provides immediate food assistance for people impacted financially by disasters (living or working in area)
- Have to qualify financially
- For people who are not already receiving CalFresh gives one month of maximum CalFresh benefits based on household size
 - No immigration/SSN requirements
 - MUST APPLY between Feb. 10 and 14; then Feb. 18th and 19th – Application period has now passed

DPSS Cash Aid

Can apply for all programs below using www.benefitscal.com or by calling LA County DPSS at (866) 613-3777.

- CalWORKs cash aid program for families with minor children
 - Must have lawful immigration status to get CalWORKs, though mixed status families can get benefits for their eligible children. For more detail, see: www.bailanetwork.org/self-help
 - Use of CalWORKs for an eligible child will not impact their parents in a public charge determination.
 - May be eligible for additional \$200 "Immediate Needs" payment if you qualify.
 - People who already receive CalWORKs can get a one-time special payment of up to \$600 to pay for costs to repair home or replace destroyed things.
 - May also request emergency homeless assistance (money for motel stays)
- CAPI cash aid program for people 65+ or who have a disability

- General Relief cash aid for adults between 18 and 64
 - o Must have lawful immigration status to get General Relief
 - Can get \$221 per month; must have very low income and low value of assets
 - Emergency aid available to prevent eviction or provide meals/housing vouchers; transportation for jobs or medical appointments

- **LA County Department of Economic Opportunity** Wildfire Relief Funds for Small Businesses and Workers!
 - "The Los Angeles County Department of Economic Opportunity (DEO) in partnership with the City of Los Angeles Economic and Workforce Development Department (EWDD) to support businesses, nonprofits, and workers impacted by the Windstorm and Wildfires of January 2025." Applications are now due Wednesday, March 12!

- Two grant options:
 - Small Business Relief Fund: Provides direct cash assistance grants ranging from \$2,000 to \$25,000 for businesses and nonprofits that experienced structural damage, equipment/inventory loss, or revenue loss.
 - Worker Relief Fund: Provides \$2,000 in direct cash assistance grants to workers who lost employment or income due to the wildfires.
 - Eligible Applicants
 - Applicants must meet all of the following requirements in order to qualify:
 - Identity: Be at least 18 years of age.
 - Residency: Be a resident of Los Angeles County.
 - Employment Status: Be employed or self-employed (such as domestic workers) in Los Angeles County at the time of the Windstorm and Wildfire emergencies that took place starting January 7th, 2025.
 - Financial Impact: Experienced income loss (temporary or permanent) due to place of work location in the emergency zones (Fire Zone, Evacuation Order Level 3 Zone, or Evacuation Warning Level 2 Zone during Disaster period.) or due to loss of their home.
 - Right to work status is not required to apply.
 - Applications here: <u>Small Business and Worker relief Funds</u> <u>Department of Economic Opportunity</u>

11. Relief Funds + Community Supports

Note: If you or your family already receives benefits (like CalFresh, CalWORKs, and SSI) and you receive recovery support through GoFundMe or other cash donation programs (like those listed below), you may be required to report those donations to the Los Angeles County Department of Public Social Services (DPSS) or to the Social Security Administration (if you receive SSI). Contact your benefits agency for guidance. Keep good records of what and when you

reported/communicated to these agencies to avoid any overpayment of benefits.

"The iRelief Fund will offer cash-assistance to low-income families impacted by the wildfires who do not qualify for FEMA assistance. Water donations are also welcomed. The Coalition for Humane Immigrant Rights (CHIRLA), the largest immigrant rights organization in California, announced Monday it is seeking donations to its iRelief Fund, a cash-assistance program which aims to assist low-income families impacted by the recent wildfires and who do not qualify for FEMA or other federal disaster relief. Every donation received will be distributed to impacted families in the form of cash-assistance to cover necessities such as rent, food, gas, transportation, and the like."

"We are providing Emergency Financial Assistance (EFA) to households destroyed or severely damaged by fires.

- o Eligibility:
 - Renters or homeowners living at residences that were destroyed or severely damaged by the above listed wildfire(s).
 - The destroyed or severely damaged residence MUST be your PRIMARY RESIDENCE. If NOT, please DO NOT apply to reserve resources for those in dire need.

They can assist with first and last-month rental assistance and help find permanent, long-term housing. Please note: We cannot assist with deposits.

For those needing temporary housing, please visit the American Red Cross website to find a shelter near your area. Staff on-site can assist you if you need permanent, long-term housing.

To qualify for rental, mortgage, or utility assistance, please submit copies of the following:

- o 3-Day Notice or Foreclosure Documentation
- o Copy of a Utility Bill
- o Disconnection Notice
- o Proof of Income demonstrating the union member's ability to make payments moving forward.
