This policy is effective from November 1, 2017. Last modified: April 26, 2018.

This privacy policy sets out how Concept:CPH ApS ("Concept") uses and protects any information that you give Concept when you (i) use our website and (ii) view ads served by Concept on third party websites ("Publishers"). The purpose is for you to understand what data we collect, why it is being collected, and how we use that information. We will refer to the Concept Publishers as well as any other websites, applications, and related services operated by Concept collectively as the "Service(s)." Concept is referred to in this Privacy Policy as "we," "us," "our," and "ourselves."

Concept is committed to ensuring that your privacy is protected. Concept does not collect personally identifiable data such as name, email, address or phone number from a visit to our website unless you voluntary supply this through written forms. If you provide certain information by which you can be identified when using this website, then you can be assured that it will only be used in accordance with this privacy statement.

Concept may change this policy from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. We are allowed to change the contents of the statements and the cookies listed at all times and without prior warning. You can consult this webpage for the latest version. PRIVACY POLICY

Concept partner with commercial website publishers to serve ads on their sites. Each publisher is responsible for obtaining all applicable consents to enable Concept to collect information from your device.

Concept does not collect sensitive information that is attributable to race, ethnic origin, sexual orientation, political beliefs, religious beliefs, union membership, or information such as the viewing of sites with sexual content or information indicating a users' specific medical condition. We do not use these types of sensitive data from one site for tailoring ads at other sites across our Publishers. personally identifiable data does not include aggregate information, which is data we collect about the activities and characteristics of users of Publishers websites. This Privacy Policy in no way limits Concept's ability to collect aggregate or non-personal information.

When you share your information with us we can make our services even better. Though we want you to understand what data we collect, why it is being collected, and how we use that information. You are always more than welcome to contact us if you have any questions.

INFORMATION WE COLLECT

When you view a Concept ad on a site which uses our Services, we may collect information about your device or the ad that you have viewed. This information does not enable us to determine your individual identity.

Information about your device: We may collect some or all of the following information about your device: device type (e.g. smartphone, tablet, etc.), operating system (e.g. iOS, Android, Windows, etc.), network provider, Internet (IP) address, which mobile browser you use (e.g. Safari, Chrome, Internet Explorer, etc.), the carrier user ID (a number uniquely allocated to you by your network provider), platform, SDK version, timestamp, API key (identifier for application), application version, iOS Identifier for Advertising, iOS Identifier for Vendors, Media Access Control (MAC) address, International Mobile Equipment Identity (IMEI), Model, manufacture and OS version of device, session start/stop time, locale (specific location where a given language is spoken), time zone, and network status such as WiFi, the geo-location of your device (using GPS or other geo-location data) and the unique device identifier of your mobile device (a number uniquely allocated to your device by your device manufacturer).

Information about the ad you have viewed: We also collect some or all of the following information about the ad you have viewed: the content type of the ad (what the ad is about, e.g. games, finance, entertainment, news); the ad type (e.g. whether the ad is a text, image, or video based ad); and where the ad is being served (e.g. the address of the website on which the ad appears). Also we collect non-private, aggregated, information from your visits to ads produced by the Concept Publishers as demographics, interests and behavior based information provided to us.

Information collected from you accessing the Concept site: When you visit our website we use cookies and various technologies and collect information passively using servers that automatically record information created by your use of the Services. This information may include your IP address, browser type, the referring domain, pages visited and order in which those pages were visited, the amount of time spent on particular screens, the dates and times of your requests, platform type, your mobile carrier, device and application identifiers, and search terms. Other actions, such as interactions with our Site, applications and advertisements, may also be collected. We may use this information to determine the frequency with which our users visit various parts of our Site, to help diagnose problems with our servers, to administer the Services, and to conduct research on customer demographics, interests and behavior based information provided to us. Such research may be compiled and analyzed on an aggregate basis so these data doesn't involve personally identifiable information.

You may also send us personal information like name and job title and contact information including phone number and email address if you are seeking a business relationship with us, request additional information from us, or if you apply for a job position with us. We collect this Personal Information from your interaction with our Site or from emails you have sent us. We use this Personal Information only to contact you or to respond to your inquiry. We store this Personal Information for a reasonable time for record keeping purposes. Personal Information submitted by you is usually deleted in the normal course of business.

As a registered person you have the right to gain insight, correct and delete the data we hold about you as well as obtain an overview of the data we store about you delivered in digital form.

WHAT WE DO WITH THE DATA WE COLLECT

Concept may use the information we collect to provide, maintain, protect, and develop new Services to provide to you. Concept may also use the information to display advertising customized to your inferred interests, preferences and locations, and to perform analysis aimed at improving our Services and technologies. The information we collect also helps us to provide filtering options for publishers and developers to manage ads appearing on their sites and in their apps, and to provide targeting options for advertisers. This helps our publishers and developer clients, for example, not to present you with ads that you have already seen, and helps our advertiser clients serve ads that are most likely to be of interest to you. If you voluntarily has provided personal information through the business relationship and consent has been giving by you, we may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided. From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone or mail.

Aggregate Statistics: Concept may share or disclose your non-private, aggregated, or otherwise non-personal information and statistics of the information we collect from your visits to ads produced by the Concept Publishers, publicly, with partnering sites, and/or with our publisher, developer, and advertiser clients. The aggregate statistics may include the measure of interest in, and use of, our Services and our site, such as overall patterns that do not describe or identify any individual user. We may disclose aggregated user statistics in order to describe our Services to current and prospective business partners, to show trends of the general use of our Services, and to other third parties for other lawful purposes.

Compelled Disclosures: We will disclose personal information when we believe in good faith that such disclosures are required by law or that disclosure is necessary, for example, to comply with a court order or subpoena; will help to enforce our Terms of Use; enforce contest, sweepstakes, promotions, and/or game rules; protect your safety or security; or protect the safety and security of the Services, us, or third parties, including the safety and security of property that belongs to us or third parties.

Service Providers: We may engage certain trusted third parties to perform functions and provide services to us. We may share your personal information with these third parties, but only to the extent necessary to perform these functions and provide such services, and only pursuant to the obligations mirroring the protections of this Privacy Policy.

International Transfers: We may share your non-private, aggregated information with clients, affiliates and other third parties described above who are based in countries outside your country of residence. While some countries may not have data protection laws that are equivalent to those of the country in which you reside, we will take all reasonable measures to protect your information in accordance with this Privacy Policy and applicable legal requirements.

Other websites: The site and the ads we serve may contain links to other sites. We are not responsible for the privacy practices of such other sites as those may have different privacy policies and terms of use and are not associated with us. You agree that we cannot control these links and we will not be responsible for any use of or information practices of such sites. This Privacy Policy does not address the information practices of those other sites.

HOW WE USE COOKIES

Websites use smart and useful techniques to enhance user-friendliness and to make the site as interesting as possible for each visitor. One of the best known techniques involves cookies. A cookie is a small file which asks permission to be placed on your computer's hard drive. Once you agree, the file is added. Cookies can be used by website owners or third parties - like advertisers - who communicate through the website you visit. Cookies allow web applications to respond to you as an individual. The web application can tailor its operations to your needs.

Using cookies is safe. It is impossible to retrace personal information such as phone numbers or e-mail addresses by using cookies. Cookies that ensure that the website can function properly

Our website uses cookies for:

Cookies through which we can measure the website's use

We use cookies to continuously try to measure how many people visit our website and what parts of the website they visit most. This tells us what components of the website draw our visitors' interest most.

The information thus gathered is used for statistics. These statistics provide us with insight into how frequently our webpage is visited, where exactly visitors spend most of their time, etc. This enables us to draft the website's structure, navigation and the contents as user friendly as possible for you. We will never trace any statistics to individuals. We use cookies for:

- Recording the number of visitors of our web pages
- Setting the order in which a visitor visits the various pages of our website
- Assessing which parts of our site need adaptation
- Optimising the website

Cookies to share the contents of our website through Social Media

Other/Unforeseen Cookies
