



## ***Russell Byers Charter School*** **Parent and Family Engagement Policy**

### ***School Year 2025- 2026***

In support of strengthening student academic achievement, **RBCS** receives Title I, Part A funds and therefore must jointly develop with, agree on with, and distribute to parents and family members of participating children a written parent and family engagement policy that contains information required by section 1116(b) and (c) of the Every Student Succeeds Act (ESSA). ## Section G: BUILDING CAPACITY OF PARENTS

**Russell Byers Charter School** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

**Various virtual workshops and training will be offered to parents throughout the school year. During the Annual Title I meeting, held each April and September, we share with parents the requirements of Title I, Part A, the State's academic standards and local academic assessments. There are three report card conferences throughout the school year, December, February, and April. This year these conferences will be held in person. During conferences teachers will discuss with parents how to monitor their child's progress.**

## **Section H: BUILDING CAPACITY OF SCHOOL STAFF**

**Russell Byers Charter School** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:
