Terms of service/usage of adoptable

Do **not** trace, edit or claim **any** artwork physically **drawn by me** as your own.

To clarify

You may claim the character as yours - just **not** my artwork itself

Changing gender, clothing and other details are allowed

as long as it's still recognizable

You may have the design commissioned by another artist

But I retain all copyrights of the original design so you must credit me

Do **not** commercially use your purchased Adopt (unless you payed the commercial fee)

By purchasing from me, you **do not** take away my right to post the Adopt artwork to **any** site I use to promote my art **as well** as post recordings of the drawing process.

You may print your virtual product piece and claim **character** but **not** the artwork/design itself.

Giving, Trading, Reselling is permissible, reselling at a higher price is not

If you trade the Adopt, the commercial rights that you purchased does **NOT** roll over to the new owner. They will have to come to me to purchase the commercial rights

payment

(this section applies to Auctions and non Ko-fi shop Adopts)

The character does **not** belong to you until payment is **fully complete**.

All invoices **must** be paid in full **before** I send you the PNG files!

Once the auction is over, whether through bidding or ab (auto-buy) I will send you a PayPal invoice to the email you have provided to me.

You will have 24hrs from the time the invoice is **sent**, to pay. If you **fail** to send payment within 24hrs **without** explanation, your order will be **canceled**, the Adopt will go to the previous bidder or be put up for bid again as well as your name being **added** to a 'Beware of this buyer' list

However, if you need an extension during the 24hrs and you **contact** me telling me so, I will **extend** the deadline an extra 12hrs from the time your message is sent to me.

If payment is **still** not fulfilled after the extension, I will have no choice but to add your name to a 'Beware of this buyer' list.

Refunds/cancellations

Once payment is made, no refunds will be available. Please keep this in mind!

If you file a chargeback against me, **your rights** to the Adoptable will be **retracted** and I have the **right** to **resell** the Adoptable to **new** buyers.

You will be **forbidden** to **purchase** from me **ever again**. Your **name** will be **publicly posted** everywhere **I want** for others to **watch out** for.

I also have **every right** to file a **complaint** and I **retain** all rights to the **money** you have given me.
