

**Today we are mobilizing to dismantle environmental racism and take action to get the California Water Boards to end regulatory capture, and really engage with the communities that their policies impact.**

**Have you ever wanted to testify for clean drinking water, dam removal or on other issues that impact the water and salmon, but the meeting was 4-10 hours away during a work day? That is not okay.**

**Take action for real community engagement today.**

**Key Points:**

- Demand increased accessibility and participation in decision-making processes:
  - Every meeting shouldn't be between M-F 9am-5pm. This excludes many working people.
  - Every meeting shouldn't be in Sacramento. Meetings must occur locally too.
  - For in-person meetings, child care is needed for parents to participate in decision making.
  - Prioritize impacted communities over corporations.
- Demand increased tribal representation
  - There are 109 federally recognized tribes in California. How many tribal representatives are on the California Water Board?
  - Consultation is not collaboration.
  - California water rights are rooted in settler colonial dispossession.
