

# Monthly USA Speaker Series: Marcelo Mena, Global Methane Hub (Saturday, December 10, 2022 | 10 am PT / 1 pm ET)



Reducing methane emissions will be one of the keys to staying within the 1.5 C warming threshold. To learn what steps are being taken to lower those emissions, this month's speaker is Marcelo Mena, CEO of Global Methane Hub, a philanthropic alliance to support methane emissions reduction efforts around the world. Mena previously served as Minister of the Environment of Chile and has extensive experience as a scientist, activist, former professor and policymaker. In his role as Minister of Environment, he spearheaded multiple international environmental initiatives including helping craft a landmark agreement to phase out coal power generation. On this month's call, he will offer his perspective on the recently convened COP27 climate conference.



# ACTION #2: Catch up on your Action Tracker reports by January 1

Politicians take note of highly organized volunteers that work together. For over 12 years, bold, consistent, and documented actions by our volunteers have produced incredible results. You are where hope resides.

#### Laser Talk: Evidence-Based Climate Communications

If you are an evidence-based climate communicator, it should not be surprising to you that COP27 ended with no mention of an equitable fossil fuel phaseout and that oil and gas have yet to be mentioned in a UNFCCC COP document.

The fact is, fossil fuel companies have more money than our governments and currently control the narrative, including here in Canada.

Honestly, what do you conclude from this behaviour?:

- COP 27 was the first time ever that Canada hosted a pavilion at a Conference of the Parties for the United Nations Framework Convention on Climate Change and our country gave a platform to the oil and gas industry. In one session with Alberta Minister Sonya Savage, no questions were allowed.
- Canada was reportedly the only country in the Organization for Economic Development and Cooperation (OECD) and G20 to have brought delegates from the fossil fuel sector.

It is so bad, research shows that most people are not making the connection between climate change, disturbed weather systems, air pollution, and deaths due to fossil fuels all around the world. On top of that, most Canadians still support the fossil fuel industry.

As well, polarization is getting deeper especially in Canada and the USA thanks to all the disinformation and media attacks on both sides of our borders. The illegal takeover of our nation's capital, and the multi-billion dollar border-blockade attack on our economy in February 2022 as well as the attacks on mainstream media in Canada are evidence that some Canadians have somehow lost their politeness.

Everyday people may not have the money or resources to combat the fossil fuel industry and the undermining of our democracies. But we do have the numbers, truth, and love on our side. The key is to use the best communications strategies possible.

We live in a democracy. Clearly breeding cynicism leads to voter apathy and then people don't vote. We must up our game.

Understandably, people become very demotivated by messaging that is cynical, has a plethora of data, and/or there are too many talking points.

If you really want to empower people and help save the planet and not be part of the cynicism loop with your writing, the data is clear: people respond best to short stories that follow this consistent pattern: problem, pathway, and then benefits. This pattern of communication is motivational and motivational interviewing is foundational in our organization.

A better world awaits. By using evidence in our communications, we will get there faster.

# Laser Talk: Canada's Carbon Pricing Policy - Updated




In June 2018, the <u>Greenhouse Gas Pollution Pricing Act</u> achieved Royal Assent and became law of the land in Canada. All provinces and territories must have a carbon pricing policy of at least \$20 per tonne by January 1, 2019, raising \$10 per tonne each year until 2022, with the flexibility to have their own carbon pricing systems which are equally stringent as the federal Backstop Carbon Pricing system. In 2021, the federal government updated its policy on recognizing the stringency of provincial carbon pricing systems and the price will rise incrementally to \$170 tonne by 2030. In jurisdictions that do not have equivalent carbon pricing policies, the Federal Backstop Carbon Pricing system will apply.

There are two elements of the federal carbon pricing policy:

1. THE FUEL CHARGE: A charge on fossil fuels that is generally payable by fuel producers or

distributors, with rates for each fuel that are equivalent to \$10 per tonne of carbon dioxide equivalent (CO2e) in 2018, rising by \$10 per year to \$170 per tonne CO2e in 2030. The carbon fee for the federal backstop policy is revenue-neutral. Between 2019 and 2021 the revenue was recycled back to the citizens in their income taxes under line 449 "climate action incentive". Starting in 2022, in provinces where the federal backstop Fuel Charge applies (currently, Alberta, Saskatchewan, Manitoba, and Ontario), will include quarterly payments at the beginning of each quarter. To give the Canada Revenue Agency sufficient time to develop the new system, payments started in July 2022 with a "double-up" payment. Thereafter,

payments will be quarterly. Of note, <u>80% of households come out ahead</u>, a finding confirmed by the <u>Parliamentary Budget Office</u> and <u>Clean Prosperity</u>.

<u>UPDATES:</u> In July 2023, the Climate Action Incentive cheques will be coming to Nova Scotia too. This was announced in late August 2022 when <u>Premier Houston's climate plan</u> was rejected. In <u>November</u>, it was also announced for Prince Edward Island, Newfoundland, and Labrador too.

2. OUTPUT-BASED CARBON PRICING: For businesses and industries that qualify, are enrolled in an Output-Based Carbon Pricing System. They pay a carbon price based on their emissions' intensity relative to the best in the class of their industry, and surplus credits are traded. This component of the act protects emissions-intensive trade-exposed industries from trade pressures and carbon leakage. However, it does not send a strong enough signal to transform Canada's energy systems to carbon decarbonize in alignment with the realities of the climate emergency we face. This assertion is supported by research by Clean Prosperity and the Parliamentary Budget Office. CCL recommends that the carbon price should be economy-wide and thus the Output-Based Pricing

## Laser Talk: Carbon Footprint of COP 26 vs China and India

The carbon footprint of COP 26 (the 2021 Climate Summit in Glasgow, Scotland) was calculated as 103,000 tonnes (1).

Comparatively, in 2020 China's carbon footprint was 14,400,000,000 tonnes (27,000 tonnes a minute) and India's carbon footprint was 2,412,000,000 tonnes (4,500 tonnes a minute). (2) Thus, in about 4 minutes, China produces as much CO2 as the entirety of the COP 26 event with India close behind at about 24 minutes.

At COP 21 in Paris (2015), India's President Modi would not sign the final agreement until his country was given technical proprietary rights from Solar City technology. This happened via negotiations between Al Gore, President Modi and Elon Musk (3).

Let's be clear. It is not the COP sessions that change the world. It's the actual work that goes on after governments have made those promises. India's solar output has increased 6 fold since then! The rest of the world has only doubled in the same time frame. (4)

GHGs will not drop on their own. The Conference of the Parties (COP) is important and their carbon footprints are a drop in the bucket compared to the overall global emissions they help to reduce.
