 - The new Title 5 GE structure will need to be implemented for fall '24, not fall '25, as previously thought. This will mean a tremendous amount of rebuilding during spring and probably summer in order to be ready for fall '24. On Thursday, Nov 9, the day after the CC's last meeting, this announcement came from ASCCC Communications:

On behalf of the California Community Colleges Regulations Coordinator, please read the following notice regarding Associate Degree Requirements:

The California Community Colleges Board of Governors approved regulatory action entitled "Associate Degree Requirements" was filed with the Office of Administrative Law and the California Secretary of State on October 17, 2023. This regulation becomes effective 30 days from the 10-17-2023 filing date or November 16, 2023.

Pursuant to California Code of Regulations, section 52010, college districts may conform their policies and procedures to the regulatory requirements within one hundred and eighty (180) days of the effective date.

Chancellor's Office Regulatory Actions Page

- Because significant infrastructure changes will be happening under the hood with all GE (and
 graduation requirement) courses, please refrain from modifying GE courses and the programs
 that they impact until under the hood expedited changes are complete. Actually, you will have
 no choice because you cannot modify something already in review. Just hold off till fall '24. Plan
 what you'd like to do, but don't create or edit anything in CurrlQunet.
- It should be fine to work on CTE and non-GE courses and programs without GE courses.
- It should also be okay to work on DEA for GE courses, provided the base course is in review.
- We're talking about 1100 current GE and grad requirement courses! Our GE structure has been bloated, an effect, in part of the old Bipartite system. We are overdue for some housekeeping, and this rebuild will no doubt trigger pruning discussions and GE applicability questions.
- This will take the entire spring term and likely go into summer. We have to preserve the current structure's history and build a new structure; we cannot simply replace the name of the GE area because that would overwrite history. And then there's the mapping and program impacts

- And while we're on the topic of "Hey, California College, it's the middle of the academic year
 and you need to make major changes by fall semester," all fifty or so Work Experience
 Education (WEE) course outlines (formerly known as Cooperative Work Experience or CWE) will
 go through expedited modification so that they display the newly mandated 54 hrs = 1 unit
 formula. If you need to revise a WEE, please don't do anything in CurrlQunet this spring. Please

wait till things are in place for fall '24. The current approval date will remain on the expedited outline.
