

## TERMS AGREEMENT The Olive Odysseys Croatia June 2019

Payment in full of this tour is confirmation that a participant of this trip agrees to the following. After the final payment of this tour, participants agree that their tour is non refundable. Trip price does not include airfare, or other means of transportation to our starting point at the beginning of the trip or at the end of the trip to or from the airport; meals and drinks not included on the itinerary, transportation costs incurred during free time on tour, fees for passports or other travel documents, or other personal expenses such as vaccinations, medications, laundry, and communications.

## **REFUNDS & CANCELLATIONS**

Any cancellation by tour participants after the full payment of the trip, will be non-refundable. The Olive Odysseys retain the right to cancel the trip for any reason, at which time tour costs will be refunded. Refunds will be for the tour price only and will not include transportation, hotel, or other expenses incurred by tour participants.

Payment of the remaining trip costs of this tour constitutes consent to all provisions listed under the TERMS AGREEMENT (this document). These provisions are referenced in this term agreement and participants are advised to take notice. The Olive Odysseys are the operators of this tour and are responsible for the arrangements and accommodations and services offered. The Olive Odyssey their employees, or agents are not responsible for personal injuries, loss, delay, property damage, medical incidents, or change of itinerary incurred by any person or tour participant out of the act of negligence of any direct or supplemental supplier, hotel, restaurant, transportation or any people rendering these services or accommodations on this tour.

The Olive Odysseys are not responsible for any injuries, death, damage, loss, or delay in any means of transportation, including carriers and rental vehicles, or by reasons beyond the actual control of the above named. Persons participating in the tour do so at their own risk and agree not to hold The Olive

Odysseys responsible for injury or death resulting from accidents.

The participants are required to purchase their own trip and medical insurance. If necessary, The Olive Odysseys also hold the right to substitute services, restaurants, or hotels listed in the itinerary with comparable services.

The Olive Odysseys also hold the right to decline or accept or retain persons as members of the tour due to circumstances beyond the aforementioned control. By participating in the tour participants acknowledge that they have the basic physical and mental requirements to perform the activities listed in the itinerary.
