#### 1.5 Reference of Relevant Rules

MathSoc follows a modified version of Robert's Rules to help keep our meetings orderly. They prevent us from talking over each other. Please wait to be acknowledged before speaking. If you are not speaking please have your mic muted. For each speaking turn focus on a single point. Everyone has the right to speak. For a motion to be discussed it needs a "mover" and a "seconder".

#### If you wish to:

- Make a new point -> 1
- Reply as part of the ongoing conversation -> 2
- Ask information about the speaking order, or relevant bylaws, or policies -> POI (Point of Inquiry)
- When you see someone else not following the speaking order -> POO (Point of Order)
- If you couldn't hear or need to take a break, etc. -> POP (Point of Personal Privilege)

Most motions at Council aren't controversial so we use a method of voting where you only need to explicitly vote if you wish to vote against a motion or abstain from voting. You can also write "Noted [Name]" to have your vote noted in the minutes. We can also use roll-call voting or ballot box voting if  $\frac{2}{3}$  of council agrees to it.

#### **5 General Orders**

A general order is an item of business that is ordered to be taken up at a meeting. Time limits to discussions indicate the point at which the Speaker will end the discussion unless Council directs otherwise.

# 5.1 Expanding the DSC and PMC Club Offices -- [Evan Girardin, Councillor Sood]

Whereas the Pure Math Club's office sees regular, significant traffic, and has seen similar traffic in previous in person terms (upward of 10 people);

Whereas the Pure Math Club is often unable to accommodate all students who wish to enter the club office, inhibiting the club's ability to maintain a welcoming environment;

Whereas the Pure Math Club's office often sees uncomfortable, heightened temperatures due to the presence of large volumes of people;

Whereas the Data Science Club currently has the smallest club office, and would likely also benefit from a larger office;

Whereas the Bioinformatics Club was recently disbanded, freeing its office space;



**Be it resolved that** Council perceives a need for additional space for both the Pure Math Club and Data Science Club:

**Be it further resolved** that MathSoc Council recommends the relocation of the Data Science Club to the old Bioinformatics Club office in MC 3028;

**Be it further resolved that** MathSoc Council recommends the removal of the temporary wall separating MC 3033 and 3034, and allocates the additional space of MC 3034 to the Pure Math Club office.

# 5.2 Allocating the Bioinformatics Club office to TechNova [Lucy Shen Business Rep, Second by ]

Whereas the TechNova hackathon organizing team (in partnership with the WiCS committee) is looking for a club room for meeting and storage purposes;

Whereas the TechNova team requires a space to host in-person organizer meetings;

Whereas the TechNova team has an urgent need for a permanent storage area to accommodate the swag items for over 500 hackers/mentors/sponsorship representatives for our Hackathon in August;

Whereas the TechNova team needs a private space to host calls with external sponsors and visits from students;

Whereas the Bioinformatics Club was recently disbanded, freeing its office space;

Be it resolved that Council perceives a need for office space for the TechNova organizing team;

Be it further resolved that MathSoc allocates the old Bioinformatics Club office in MC 3028 to the TechNova Organizing team;

There was a point of order on if Council has the power to consider 5.1 and 5.2. The Speaker ruled they would be in order with an amendment.

5 abstentions. VPO, VPC noted in abstention.

VPA motioned to strike both 5.1 and 5.2 and add a discussion item to New Business on the topic of the BIC room. VPO seconded the motion. It passed with a 2/3rds majority.

### 5.3 Update to Clubs Policy [VPA, VPI]



**Whereas** the Executives have integrated the feedback of Council into the proposed amendments to the Clubs Policy; then

VPA summarized the motion. The motion passed.

VPO moved to discuss 5.4 after 6.2. There were no objections.

## 5.5 Volunteer Appreciation Budget Increase [Motioned by VPI Wang and seconded by VPA Macri]

**Whereas** the VPI's budget for Volunteer Appreciation is insufficient for the Volunteer Appreciation dinner;

Whereas past Volunteer Appreciation budgets have been over \$5000;

BIRT Council allocates an additional \$500 to the Volunteer Appreciation budget and

**BIRT** unused funds from the VPI budget may be allocated to Volunteer appreciation

VPI summarized the motion. Motion passed.

## 5.6 Remuneration of Speaker, Deputy Speaker and Secretary [VPO Saha, Councillor Tapley]

**Whereas** Council must decide amounts to accord to Speaker, Deputy Speaker, and Secretary based on performance during Winter 2022 term

Be it Resolved that Speaker [Sabrina Berbari] be awarded \$250

**Be it Resolved that** Deputy Speaker [Keaton Tapley] be awarded \$100

**Be it Resolved that** Secretary [Annie Zhang] be awarded \$180

After a discussion, it was agreed to fill in the blanks with the numbers above.

Motion passes.

Councillor Tapley and Councillor Berbari noted in abstention.

#### **6 New Business**

Any Councillor may raise any item of concern during new business. Generally, long discussions without a specific motion before Council should be avoided, and are technically against the rules of procedure. ## **6.1 MathSoc Membership Entitlement [Discussion] [VPO Saha, Councillor Tapley]**

**Whereas** it is in the best interest of Council to ensure that the Society is not only retaining but working to increase membership to support funding requests for the activities and events of the Society and Clubs;

**Whereas** as we return to more in-person activities, it is important to ensure that MathSoc Executives and Club Executives have a common understanding of MathSoc membership entitlement;

**Whereas** the following document outlines the Society's current, and pre pandemic, practices pertaining to membership entitlement; and

**BIRT** Council has a preliminary discussion regarding membership entitlement and provides additional comments to the attached document.

There was a discussion on the exam bank. Councillors expressed that the exam bank should be open to everyone. The VPA said that we currently sort of say it's for Math students but don't have the technology to check it, right now only people with a UW login can access the exam bank. Councillor Sood expressed that we can say what we want with the goal of getting the technology setup in the future when it is feasible.

MEF Director Sharma asked about restricting academic events like resume critiques. VPA explained why it is desirable to restrict those events to fee-paying MathSoc members, namely the amount of time it takes for resume critiques. The VPA and VPI talked about the need to trust the judgment of executives.

Sharma expressed worry of a reputational risk to MathSoc if MathSoc is strict with fee enforcement but MathSoc Clubs are not. The VPA and VPI expressed their disagreement.

#### **5.4 Mathsoc Memberships [VPA Macri, Councillor Bector]**

Whereas the MathSoc membership voted to return to the refund model; and

**Whereas** MathSoc does not have a consistent policy for how to handle people who did not pay their free; then

**Be it resolved** that MathSoc calls on the University to respect the decision of the members and allow MathSoc to return to the refund model; and

**Be it further resolved** that MathSoc calls on WUSA to prioritize helping Societies to return to the refund model; and

**Be it further resolved** that until MathSoc is able to return to the refund model, that Council directs the Executives to be reasonably strict with offering free services only to those who have paid their MathSoc fee, with the exception of snacks in the MathSoc office; and

**Be it further resolved** that the Membership Entitlement document in 6.1 is a good reference for Executives to use; and

**Be it further resolved** that when denying such services would go against common sense (for example, when giving out food that would go bad otherwise) the Executives may exercise their best judgment.
