

Privacy Policy

Day 1 Bags uses industry-standard SSL (Secure Sockets Layer) encryption to protect the confidentiality of your personal information and the security of your online transactions. Day 1 Bags online donations are processed through Paypal Giving Fund where there are no fees, Venmo, Direct Deposit into our bank account, or by mail. All online transactions are confirmed by a follow-up email.

Emails & E-Newsletters

Periodically, Day 1 Bags sends emails and eNewsletters to our opt-in lists to keep supporters informed of news and events related to our mission. To receive these updates you must provide Day 1 Bags with contact details including your name, street address, and/or email address. This information will be held in complete confidence and Day 1 Bags will NOT sell, rent, trade, or otherwise reveal this information to a third party. You are given the option to remove your name from our email list within each email/eNewsletter update.

Information We Collect and How We Use It
