**Re: Letter of Support for AB 2772 CCIDC Certified Interior Designers Title Act (Business and Professions Code Section 5800) Sunset Review**

This proposal is contained in Section 10, page 70 of the California Council for Interior Design Certification's report to the Assembly Business and Professions Committee and the Senate Business, Professions, and Economic Development Committee titled "New Issues." The requested clarification would modify Sections 5800, 5805, 5806, and 5812

of the existing statute and would provide greater statutory clarity and consistency for both regulators and regulated professionals.

Additionally, I respectfully request that the Committee extend the sunset date of this statute to 2031, in accordance with the standard practice of the committees. Continuation of this program advances the Legislature's intent to protect the health, safety, and welfare of the public by ensuring clear professional standards and promoting the integrity of the interior design profession in California.
