

BACKGROUND INFORMATION

ELECTRONIC SURVEILLANCE

AUTHORIZED (Canada/U.S. Gov. Security- Military - NORAD)

Since October 2017, we are convinced our house was electronically monitored for conversations in house, telephone landline and cellular, as well as data transfer, text messages, e-mails, video conference sessions - all internet activities in general.

Surveillance under the governance of the Canadian / U.S.A. (NORAD) military and high probability NSA (U.S.A.) / CSE (Canada) including other agencies tied through the process of surveillance setup, upkeep, administration. Third parties such as Bell Canada and others are directly involved in setup and upkeep.

Reason for Surveillance: My first exchange with MUFON - - Approx. 40 minutes after response email from MUFON Director (K. Marsden), a black helicopter at very low altitude, flew over the house. From the point forward - almost daily basis - we experienced aircraft fly-overs.

Immediately, I started to "time" their arrival usually 30-45 minutes after exchanges with a select few individuals - exchanges such as text messages, paranormal/supernatural pics or videos as well as answers to inner queries and insights that would come to mind-heart before/during/after (many) sightings in the sky. All documented and available upon request.

[For my own sanity - I documented, kept my exchanges (e.g. messages, emails, Skype chats) - I also took videos and photos of the fly-overs - Why? Aha. Well, how would I explain this period in my life IF it ever came up or had to be told? *Thank goodness I did* -This information (fly-over period) is available upon request. As I come from a security background, I understand why this happened -The surveillance¹.

Fly-overs stopped on November 29, 2017. (Yes, I know why. Information available upon request). Today, I consider them allies of sort.

UNAUTHORIZED - ILLEGAL ELECTRONIC MONITORING FOR SELF-SERVICE/NEFARIOUS REASONS

Since December 2017, we highly suspect Bell Canada was the weak link - security breach - through illegal means (leak in the organisation - employees?) -

The instigators are, in order of priority, Michelle Guertin (lead command), Anton Trepanier (2nd lead command) and Terry Lepage (private investigator - working both sides - riding dirty - - Agent of Deception paid off by Michelle Guertin to give disinformation to Mark Smith). Mark contacted Terry Lepage in January 2018 (I believe) because we suspected that we were illegally monitored by Guertin and Trepanier. Lepage, nice chap, for good old days, he offered his investigative services "pro-bono". Right.

¹ Disclosure is not as simple as some people think - it unravels how average joe public perceives the world. Out of compassion, work need be done - it's not the technological aspect, it's the fear at spirit level - blinds people - fear and prejudice - erratic judgement - even the most innocent become a monster as one defends battles "whatever is shaking their spiritual belief" in the name of his/her belief systems -Why? to bring back sense of security through conformity (fads, norms and rules of conduct of the era as it has been the case throughout humanity's history).

Between April 24 - 28, 2018, Mark discovered that Terry Lepage was paid off by Guertin to give disinformation about my online projects and activities. Then with timely calls by Guertin and Trepanier, it escalated to April 23, 2018 assault incident.

WHAT FOLLOWS SHOWS THE ESCALATION THAT LED TO THE DESTRUCTION OF OUR 10-YEAR RELATIONSHIP - THIS WAS ACHIEVED THROUGH PSYCHOLOGICAL AND EMOTIONAL MANIPULATION -THE MANIPULATORS ARE THE THREE INSTIGATORS (GUERTIN, TREPANIER, LEPAGE) WHO WERE PRIVY TO OUR PRIVATE AND PERSONAL CONVERSATIONS, COMMUNICATIONS AND INFORMATION - AND SEXUAL ACTIVITIES (THIS WAS TRACKED BY SECURITY DEPARTMENT AT BELL CANADA) - OUR INTIMATE MOMENTS WERE RECORDED AND LISTENED TO OVER AND OVER AGAIN -(INFORMATION AVAILABLE FROM BELL).

THIS IS PSYCHOPATIC BEHAVIOR - SINISTER AND EVIL WHAT I CALL "SATANIC'.

The motive is money. Mark Smith has inherited a considerable sum of money (multi-\$\$\$) - such a big amount - personally it's a very serious responsibility - a burden >>> a target / heat score for JEGs (Jealous, Envious, Greedy) people. Anyway. Welcome to Earth.

Recurring behaviour patterns and trends were detected

Once or twice is a coincidence - trends and patterns in response to our exchanges - signature behaviour repeated over and over again - It was quite obvious - once they knew I knew - they became sinister as shown in recordings.

- ✓ They would share knowledge with Mark Smith over telephone calls - information they could not have known unless they had read what I'd typed or said on Skype - usually posted 10-20 minutes before Trepanier and/or Guertin called and allude to the uploaded information.
 - Uncanny knowledge of most recent private conversation between Mark and I - in the form of questions or comments based on what we'd just discussed.
- ✓ During these calls, Guertin and Trepanier instilled great distrust in Mark toward me. Through character defamation, they almost convinced him I was evil, up to no good that I chatted with many men (flirt, sexual in nature) and, I WAS CREATING A DATING WEBSITE - I WAS FULL OF SECRETS ...Twisting information by using tit-bits of conversation topics in our home or Internet -- feeding his insecurities - sexual vulgar comments (from son) - and now knowing they were listening to us while we were intimate (very sensual talk from female (me) being played over and over. WTF.
- ✓ Master manipulators for self interest purposes - inheritance to son and bio mother -. "Watch her Mark! We know people like her, she is not what you think. Please Mark get away from this gold-digger- let us help you get away (as they have done with all of Mark's past relationships - they (Trepanier, Guertin) have destroyed 2 marriages and any potential long-term relationships between these marriages. I call her (Guertin) , "The Handler".

What was attempted - and will be demonstrated in the video / audio recordings collected during this period.

PLAN A

Break up the relationship -They have great success rate with past break-ups

[Let's get him so hurt and distrustful toward her - he will be vulgar - She will kick him out of

her house - call police - He will call Guertin, she will arrange transport, what he needs until he gets to her. Easy as pie.]

PLAN B

Eliminate/ Remove Lyn Champagne - Get rid of her

[I overheard them, Mark even alludes to it in audio recordings. Conspiring to set me up with hard drugs from Thailand]

Then they shifted to emotional/psychological manipulation tactics - feeding Mark's insecurities which led to erratic behaviour and turmoil in our home (as shown in recordings). During this period, Mark told me to kill myself - Trepanier had the "too uncanny" habit of calling or texting as we were getting together, during and immediately after intercourse - Mark stopped answering / eventually had to close the phone - they were listening as confirmed by Bell Security Centre -The calls consisted of vulgar comments about me or of general sexual nature ("*Son, how uncanny you should ask me that question.*" << too many times.)

A SENSE OF PANIC exploded ; -) WHEN THEY REALIZED I HAD RECORDINGS of EVENTS that showed their involvement and influence over Mark - Once they overheard via electronic monitoring and in some cases, saw/heard recordings, Guertin became agitated. The song and dance frenzied - now they wanted him to be inducted as a Knight Templar - And every morning (1-2 week period) incoming calls to Mark from different high level Templar Officials. The importance of his son's standing in the Templar organizational structure (matriarch Guertin family men are Templars, Trepanier would be the 14th generational templar). Since they could not get us to break up, I was to be inducted in Knight Templars as Mark's consort . We eventually learned that Guertin was hoping to be the consort - however, that was not to happen as family secrets - through my Skype 1-person conversation - exposed the age difference in 1978 btw Guertin and Mark. How she got pregnant (as planned) to Mark's dismay (13 yrs old) - A boy (Trepanier) was born in December 1979.

So I published the fact, in 1978, Guertin (25 yrs old), a law clerk, had sexual intercourse with Mark (13 yrs old) - a boy who'd been thrown out of his home by step-father - vulnerable and alone - just a kid who felt unloved - no one cared. Pedophile woman has been there since then - She's the Handler. He wants out. As she said to his bio-mother (Lavergne), "Theresa, you well know that he is mine at the end of the day." (From Lavergne's mouth to Mark's ears).

Over several weeks, Trepanier plead Mark to come to Montreal for 3 days. Often overhead Mark during calls (April): "*Dad, after these three days, you will not want to be with her. Please Dad, just 3 days, please.*"

The induction in Knight Templar was cancelled by us. After one week of deliberation - we decided not to join the Knight Templars - Well ! It morph into psychological manipulation through mind game - we were e-monitored by them after all - so they had advantage - spy games mostly being followed by individuals associated with Templars because of Guertin and Trepanier (documented herein). Easy to detect - then looks of intimidation - yeah yeah yeah.

Then it became dark and sinister - They did not hide it - They reminded me of Mr. Burns (Guertin) and Smithers (Trepanier) from cartoon series "The Simpsons". Character defamation resumed - they did not care - even if it showed or not - I was a commoner in their eyes. A puke. A wannabe as she called me. Mother and son work well together - the child learned from maman when very young. Somewhere I faintly hear > "*Did I do good Maman?*"

Guertin panicked now and wanted him in a hospital - to clear herself and her son - no involvement, innocent through threats and other nefarious means.

PLAN C Push Mark to brink of mental breakdown - let's try to legally declare Mark unfit to take care of himself

Look! At his erratic violent outbursts. Guertin and Trepanier wise counsel to Mark - not to worry you will be institutionalized in the best facilities your money can buy - we know what we are doing - with power of attorney - we will ensure you are well taken care for the rest of your life. Come..

PLAN D TO LOSE HERITANCE (T. Lavergne (Bio Mother-Estate Executor) is in on it:

- A) Declare mentally unfit to be institutionalize, or**
- B) Instigate for conflict in relationship - push him to be physically violent - get him long jail term. She (me) out of picture. She has no claim.**

On April 29, 2018, through series of events, Mark's bio-mother (Theresa Lavergne) and his sister (Nicole Periard) demonstrated alliance / in collusion with Guertin and Trepanier. Mark institutionalized for life or jailed for a long time. By getting him out of the picture, the estate money is managed by T. Lavergne - she can do as she pleases - she is ally with Guertin and Trepanier - alliance through fear control and blackmail. They will divide among themselves. Fuck Mark (as they always did anyway. Difference now is that is really shows. The addiction of money pulls out the ugliness, the real face.)

IMPORTANT - I believe PLAN D came in effect WHEN Guertin and Trepanier realized I had evidence / proof to show their psychological/emotional manipulation - Through illegal monitoring, they viewed videos, they heard everything. They know I have this evidence -and that's when they turned the tables on Mark,

"See how violent he has become?" He is sick. I remember when Guertin got a rude "uh oh" moment - With authoritative urgency, her talk/tone became forceful and total dislike of me - I had been wanting to meet her since August 2017 - she avoided me - we have never met nor her son.

Guertin, Trepanier story line changed / their discourse - I am paraphrasing here:

Mark must be removed from here (our home) - I was making him sick - A ruthless Gold-digger, etc. - Son and her persisting that they call for an ambulance - to get him out of here. Son crying for his father, please Dad get away from that woman (me) - she is cheating, she is not what you think, Dad" - Then from the hospital they would transfer him to a facility in Toronto where Guertin lives. Mentally unfit in order to cover her involvement in this case - no fault of her or the son. Mark was mentally deranged. Thank goodness We got him out of there. Who knows what that woman would have done next. Right.
