Call to Order

Trustee Kalogerakos, on behalf of President Farr, called the meeting to order at 7:00 p.m.

Approval of Minutes

Trustee Shine moved to approve the minutes of the November 10, 2025, General Session. Trustee Ross seconded the motion.

Police Report

Chief McEnerney reported on the ticket writing (approximately 70 written in the past month), which was primarily by delivery personnel.

The board discussed a sewer cap that had been damaged, and the Chief had placed cones around it to prevent any residents from getting injured. Sarah Ronan is contacting a few contractors to get the work done, and Trustee Kalogerakos is going to contact a previous contractor that the Village has previously used.

Approval of Bills

Trustee Kalogerakos moved to approve the monthly transaction report for December 2025 as prepared by Village Administrator Michelle Shapiro. Trustee Burden seconded the motion.

Emergency Services Department

Village Administrator Michelle Shapiro reported that we had collected \$4600, which is more than we had previously collected, and anticipates a higher collection given that Zelle is a method for the residents.

Trustee Ross and the board will discuss the disbursement in January.

Building and Zoning Department

Public Buildings and Grounds Department

Trustee Shine had nothing to report.

Finance and Administration Department

Trustee Miller shared that our financial position remains strong.

Trustee Miller discussed passing a 4.3% levy increase that will support the increases the Village has had with our fire and emergency service support, water, and any other areas.

Trustee Ross moved to approve the ordinance levying taxes for all corporate purposes for the Village of Golf for the fiscal year beginning May 1, 2025, and ending April 30, 2026. Trustee Landman seconded the motion.

Trustee Ross moved to approve the ordinance of the Village of Golf abating the 2025 tax levy for \$800,000 general obligation bonds, series 2019. Trustee Miller seconded the motion.

Audit findings were presented by Hannah Cullerton of Lauterbach & Amen. She reviewed all areas and findings at an executive summary level and reported that the Village of Golf is doing well, and that she also appreciated working Village Administrator, Michelle Shapiro.

Trustee Ross moved to approve the audit report. Trustee Landman seconded the motion.

Streets and Sanitation Department

Trustee Kalogerakos shared that there was a stop sign hit on Clyde and Overlook, which was repaired the same day and billed to the insurance company.

Utilities Department

Trustee Landman reported on the water variances (a loss ratio) and that we are closer to where we are expecting. Glenview is raising our water rates from \$3.36/1,000 gallons to \$4.10/1,000 gallons. We should pass an ordinance amending the annual fee schedule to increase our rates to residents from \$8.30/1,000 gallons to \$9.50/1,000 gallons to take effect on January 1, 2026.

Trustee Ross moved to approve an ordinance to update the Village Fee schedule to increase the water rate (see above). Trustee Shine seconded the motion.
