### 1.1 Terms and conditions

- a) This app does not have a registered account entry and will not collect any personal information from you. This app only needs to open the camera permission (it will prompt before using the app) and collect fingertip light to calculate heart rate by self-developed algorithm.

## **1.2 Information use**
