## <u>Terms & Conditions – Unacademy Bank Exams Free Scholarship Test</u>

- 1. The Unacademy Bank Exams Free Scholarship Test ("Test") is a free test organized by Sorting Hat Technologies Private Limited ("Unacademy"). The Test shall be valid only within the territory of India.
- 2. The Test shall be governed by the following Terms and Conditions as well as the Terms and Conditions of the platform, the online Privacy Policies and Community Guidelines available on the Unacademy website (www.unacademy.com)
- 3. Those participating in the Test shall be hereinafter referred to as the "Participant/s".
- 4. In order to become a Participant in the Test, the Participants must conform to the following eligibility criteria in addition to the Test specific eligibility criteria listed in these terms and conditions:
  - (i) an Individual;
  - (ii) an Indian citizen;
  - (iii) residing in India;
  - (iv) legally eligible to enter into a contract;
  - (v) must be a registered user of the Unacademy platform;
  - (vi) must be between the ages of 21 and 35;
  - (vii) currently pursuing or have graduated with an undergraduate degree and preparing for Bank Exams.

Unacademy shall verify the information based on the criteria mentioned above provided by the Participants. If any of these criterias are not met, Unacademy has the sole discretion to disqualify such candidates from the Test or withhold any Prizes.

- 5. To participate in the Test, the Participants are required to adhere to the following steps: Log into your Unacademy account.
  - (i) Participate in the Test while it is live and active on the Test site;
  - (ii) Participants ought to attempt the Test live to remain eligible for all the Prizes.
- 6. Responses to the Test questions should be submitted by the Participants while the Test series is live and available on the Test site. Participants can begin the Test once it is live, but the Test will end at the stipulated end time automatically.
- 7. The Test shall be conducted on 23 June, 2024 or on any other dates that may be communicated by Unacademy.
- 8. Results along with the final ranks shall be declared within 30 days after the test.
- 9. There is no entry fee or participation fee payable by the Participant/s and Unacademy does not accept any form of payment to be able to participate in the Test.
- 10. The Participants shall be eligible to win the following Prizes ("Prizes") stated here under and such Prizes shall be subject to the Terms and Conditions are given herein. The details of the Prizes shall also be as given on the Unacademy website or as communicated over email or any other mode of communication. If a participant is/was a plus/iconic/Store/Ualite user in Unacademy the participant will not be eligible for

any rewards or scholarships. Also, The Participants who are eligible for any rewards will get delivery within 90 days.

- 11. Ranking Criteria: Participants securing the highest marks in the least possible Test time shall be used as the criteria to determine the ranks. In the event where two or more Participants secure the same mark, the time taken to complete the Test shall be used as a tiebreaker and the Participants with lesser time taken to complete the Test shall be ranked higher.
- 12. Any ranks/marks granted before the official announcement of the results shall be provisional and cannot be used to claim any rewards, certificates, etc. by Unacademy.
- 13. Collection of Prize shall be subject to:
  - (i) Upon successful completion of the process i.e., responds within 7 days of communication from Unacademy team
  - (ii) Verification of ID
  - (ii) Provision of correct details (address, phone number)

- 31. The product algorithm evaluates the Participants based on the speed and accuracy of the answers to be displayed on the leaderboard.
- 32. Unacademy has endeavored to make all reasonably practicable arrangements to minimize communication system difficulties or any other technical issues but can make no guarantee thereof and shall not be liable for any failures in the same. Unacademy shall not be responsible and/or liable in any manner whatsoever in case the Participant is unable to participate due any technical issues or due to the issues with their internet provider, hardware, facility provider, etc.
- 33. Unacademy will not be responsible, in case anyone is unable to participate in the Test on account of not having access to Test.
- 34. Unacademy reserves the right to modify, add or delete any of the terms and conditions at any point of time at its sole discretion without serving any prior intimation.
- 35. Any disputes with respect to the Test shall be governed by and construed in accordance with the laws of India, without reference to principles of conflict of laws and the courts in Bangalore shall have the exclusive jurisdiction to determine any disputes arising out of, under, or in relation to, this Test.
- 36. Top Ranker shall assign the right to use their name, image, or visual representation, comment, or statement, in any media for promotional, marketing, and advertising purposes or any other objective by Unacademy, as deemed appropriate by Unacademy.
