Information We Collect

- Information You Provide:
 - Account Information: If you create an account, we may collect your name, email address, and any other information you choose to provide.
 - User-Generated Content: We may collect the cocktail recipes, reviews, and images you share through the App.
- Information Collected Automatically:
 - Device Information: We may collect information about your device, such as the device model, operating system, IP address, and unique device identifiers.
 - Location Data: With your permission, we may collect precise location data if you use location-based features within the App.
 - Usage Data: We may collect information about how you interact with the App, including pages viewed, features used, and time spent in the App.

How We Use Your Information

- Provide the App's Services: We use your information to operate the App, provide features, and personalize your experience.
- Improve the App: We analyze usage data to understand how users interact with the App, and make improvements to its design and functionality.
- Communicate with You: We may send you communications about your account, App updates, or marketing materials (if you opt-in).
- Alcohol-Related Considerations: Because the App focuses on alcoholic drink recipes, we take special care to avoid advertising or directly targeting individuals under the legal drinking age.

How We Share Your Information

- **Third-Party Service Providers:** We may share your information with third parties who help us operate the App, such as analytics or cloud hosting providers.
- **Law Enforcement:** We may disclose your information if required to do so by law, regulation, or a legal process (e.g., subpoena or court order).
- **Business Transfers:** In the event of a merger, acquisition, or sale, we may transfer your information to the new entity.

Your Choices

- **Account Settings:** You can update or delete your account information within the App's settings.
- **Location Permissions:** You can control the App's access to your location through your device settings.
- **Marketing Opt-Out:** You may opt-out of marketing communications by following the instructions within the communications or by contacting us.

Security

We implement reasonable security measures to protect your information, but no system is completely secure. You are also responsible for safeguarding your account credentials.

Children's Privacy

The App is not intended for individuals under the legal drinking age.

Age Restriction

The App is intended only for individuals who are of legal drinking age in their country of residence. By using the App, you represent and warrant that you meet this age requirement. We take underage access to alcohol-related content seriously and may take steps to verify your age if necessary. We do not knowingly collect information from such individuals that are not legal drinking age. If you become aware that a child has provided us with information, please contact us immediately.

International Transfers

Your information may be stored and processed in countries outside your region of residence, including Sweden. Privacy laws in other countries might differ from the laws applicable in your jurisdiction.
