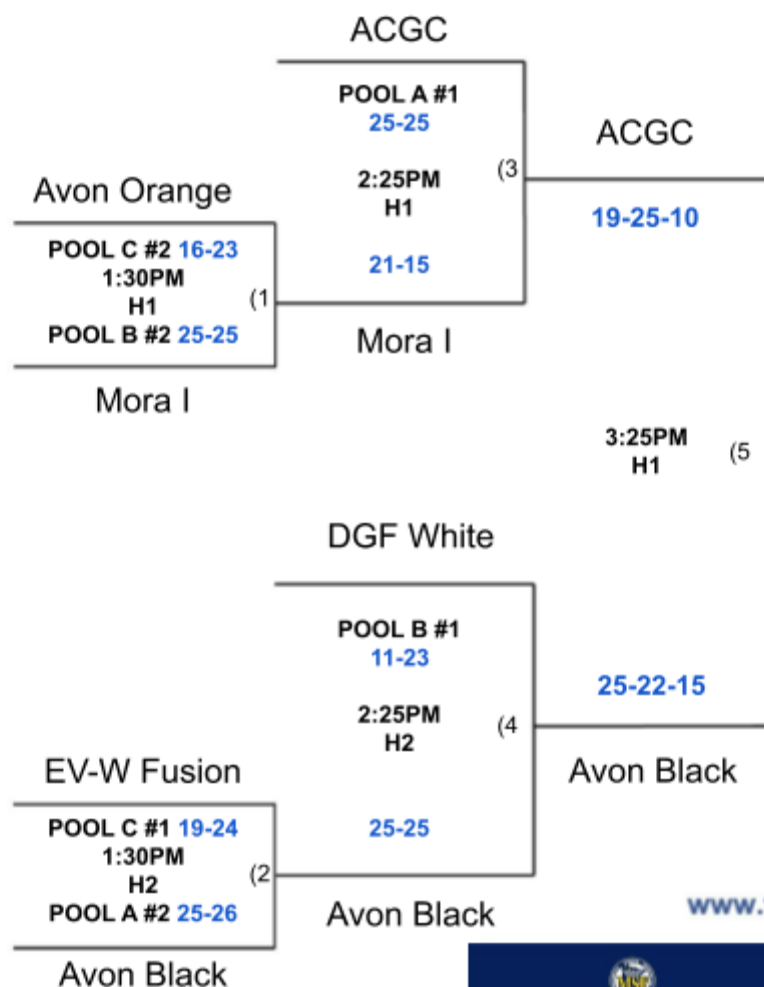
TOURNAMENT SPECIFIC INFO

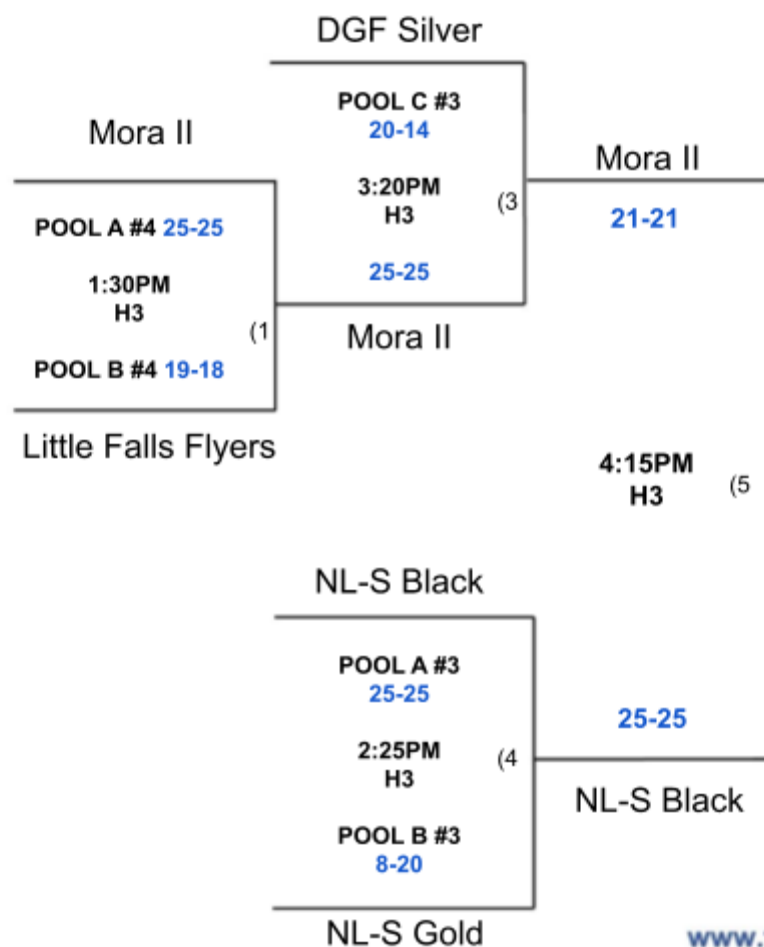
