Credo High School Board of Directors – Public Participation Guidelines

Credo High School (“School”) welcomes your participation at Board meetings. The purpose of a public meeting of the Board of Directors (“Board”) is to conduct the School’s business in public. We value your interest in our school community and your respectful participation.

To ensure meetings run efficiently, fairly, and in compliance with the law, please follow these guidelines:

1. **Agenda Access:** Meeting agendas are posted on the School’s website at [Credohigh.org](https://credohigh.org). Copies are also available at the meeting.
2. **Public Comment on Agenda Items:** Comments on agenda items will be taken at the time the item is considered. Each speaker is limited to three (3) minutes.
3. **Speaking Procedures:** Please come to the podium, state your name (and, if you wish, your city of residence) before speaking. Adhere to the time limits. Time may not be transferred (“ceded”) to another speaker.
4. **Virtual and Written Comments:** Public comment will be accepted in person only; there is no Zoom comment option. Written comments may be submitted in advance to Board@Credohigh.org. Written comments will be shared with the Board and read aloud during the meeting.
5. **Standards of Conduct:** Comments must be addressed to the Board as a whole, not to individual members, staff, or other attendees. Personal attacks, profanity, or disruptive behavior will not be allowed. The Board President may rule speakers out of order for failing to follow these guidelines.
