



# Student Sexual Harassment & Gender-Based Discrimination Report

If you have experienced or witnessed an incident of sexual harassment, sexual assault, LGBTQIA+ bullying or other form of gender-based discrimination you can report it directly to Eugene School District 4J through this form. Once 4J receives a report, we will work with your school to take specific action to stop the harassment, prevent its recurrence, and remedy the impact on individuals and the community.

### Confidentiality, Mandatory Reporting and Anonymous Reports

The information in this form is private, not confidential. That means all efforts to protect your privacy are assured and only those who "need to know" will be aware of the details of your report. However, referrals to the Department of Human Services (DHS) are mandatory when an incident involves abuse of a minor child. While you are able to make an anonymous report, be aware that it is very challenging for the district to take action without a name and contact information. Please share as much information in your report as you are able.

- SEXUAL HARASSMENT/BULLYING** can happen in person, by text or on social media. It includes things like making sexual jokes, comments or gestures; spreading sexual rumors; posting sexual comments, videos or pictures; taking, sending or asking for nudes; touching or grabbing someone in a sexual way; sextortion by sharing explicit images to coerce or threaten.
- SEXUAL ASSAULT** happens when sexual bullying gets physical. Forcing another person to do sexual things without their consent is sexual assault or rape and includes unwanted kissing, sexual touching/ groping, oral sex or intercourse. When someone is unconscious from drugs/alcohol or is being coerced and threatened, they cannot consent to sex. Even if the sexual assault happened off-campus, it can make being at school feel unsafe for the person who has been harmed, and they are entitled to protections.
- TEEN DATING VIOLENCE** is when sexual, emotional, verbal and/or physical abuse happens between two people who are in an intimate relationship. It often includes controlling behavior that isolates someone from their friends and family, causes them to feel unsafe when together and makes them scared to break-up. (Cyber)stalking is a pattern of behavior intended to cause fear or intimidation.
- LGBTQIA+ BULLYING/DISCRIMINATION** targets students because of their real or perceived sexual orientation, gender identity or gender expression and makes school an unsafe and harmful environment. It can include verbal and physical bullying, sexual harassment, refusing to use preferred pronouns, outing someone and providing unequal educational opportunities and resources.
- SEX-BASED DISCRIMINATION IN ATHLETICS** occurs when girls' sports teams, and female student athletes, are denied the same resources and opportunities as boys. This may include fewer seasonal team options, lower quality equipment and fields, fewer chances to compete and advance, less funding for uniforms and travel and/or less student recognition and leadership opportunities. This can also occur when female athletes are bullied on mixed-sex teams or by their male coaches.
- PREGNANT AND PARENTING TEENS DISCRIMINATION** happens when students who are parents, or expecting to have a baby, are treated unfairly at school. This can include shaming them, not being flexible with their schedules, refusing to make accommodations, pushing them out of their school, and/or denying them the same opportunities as other students.
