# PHI 401: Majors Seminar: Procreation and Future Generations

# **DESCRIPTION:**

We will discuss a number of controversial topics concerning the ethics of procreation and obligations concerning future generations. These topics include: Is it morally obligatory, or even morally permissible, to procreate? May the state intervene in procreation decisions? Are we morally obligated to adopt rather than have a genetically related child? Can someone be harmed, benefited, or wronged by being created? Can embryos or fetuses be harmed, and do they have rights? Is it permissible to select against disability? What effect does adding more people have on the value of the world? Is there any principle that determines the value of the world based on the number and quality of life of the individuals in that world? How should we take the interests of merely possible people into account in our deliberations?

Since this is a majors seminar, the course will largely be focused on the development of important philosophical skills, including the ability to extract an argument from a philosophical text and explain it in clear, jargon-free language, and the ability to sustain a line of argument over several pages. You will do a substantial amount of independent research, and will write a lengthy term paper that incorporates this research. Class participation will be emphasized, in the form of attendance, contributing to discussion, asking questions, and giving a class presentation.

CLASS MEETINGS: The format of the course is in person. Given the pandemic situation, we will need to remain open to the possibility that the format may change at some point, but as of now the plan is for every class to be held in person. We will follow all university safety requirements, which include wearing masks.

**O**FFICE **HOURS:** My office hours will be held by zoom. If you want to chat with me over zoom, just send me an email with a few possible times you can meet.

**Texts:** All required readings will be available on Blackboard.

# Course requirements:

- **1. TERM PAPER.** You will write a substantial research paper, 12-15 pages, on some philosophical topic related to procreation and future generations. Topics must be approved by me. The term paper is worth 50 points. It is due **Tuesday, May 10 at noon**. More information on the term paper will be distributed later.
- **2. Short Paper.** You will write a short paper, less than 5 pages, on some topic we have discussed in class. The short paper is worth 20 points. It is due **Thursday**, **March 10 at noon**. More information on the short paper will be distributed later.
- 3. Critical summaries. You will submit brief critical summaries of three recent articles or chapters you have found in your own research (*not* articles we are discussing in class) as you work on your term paper. For each article you read, you should submit a one-page critical summary in which you *very briefly* explain the main thesis or argument of the paper along with some question or criticism. Those summaries are due **Tuesday**, **April 12 at noon**. You get 10 points for completing this assignment.
- **3. Presentation.** During the last three weeks of the semester you will do a class presentation. The presentation may be on the topic of your term paper but that is not a requirement. The presentation is worth 10 points. More details will be provided later in the semester. If you want to do your presentation earlier in the semester, please let me know.
- 4. Questions: You are expected to do all the reading assignments and submit questions in the discussion forums on Blackboard every week. Questions should be based on the reading assignments. Since this is a seminar-style class, a significant amount of class time will be spent discussing these questions. Questions must be submitted by 11pm the day before the class when we discuss that reading. Your question must be a philosophical question that engages with a main point or argument of the article in question. You will get one point per question, for a maximum of 10 points. You may get credit for only one question per reading assignment, though of course you can ask as many questions as you want.
- **5. A**TTENDANCE AND **P**ARTICIPATION: You are expected to attend the class meetings and be ready to participate. How well the seminar goes will depend on how many students come to class and are prepared for discussion. It is also a sign of respect to your peers to come to class and hear their presentations. I do not take attendance or give participation grades.
