Indent. Provided a certified proofread or Grammarly report. The Turnitin report must be attached, with no more than 15%. AI-powered writing assistants are only accepted for grammar checking.

- **Proofreading Documentation**
 - Submit a proofreading report or a Grammarly report
- **Plagiarism Check**
 - Submit a Turnitin report with a similarity index of $\leq 15\%$
- **File Format**
 - Submit the article in a Word file format (5,000–8,000 words)
- **Abstract**
 - Include a structured abstract (maximum 250 words)
- **References**
 - Format references according to APA 7th edition guidelines
- **Figures and Tables**
 - Ensure all figures and tables are embedded within the document
- **Author Requirements**
 - Include at least one author from an international or industrial institution to qualify for a 50% discount
