

“POP VAULT AT LA COMICON HOT 107.3 FM SWEEPSTAKES”

OFFICIAL RULES

Residents of Texas Only

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.

A PURCHASE, PAYMENT, QR SCAN, OR SMS OPT-IN WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE TEXAS AND WHERE PROHIBITED.

1. Sponsor & Administrator

Iconx, Inc. (d/b/a “Iconx.io”), 1718 E. Speedway Blvd. #111, Tucson, Arizona, 85719 (“Sponsor”).

2. Eligibility

Open only to legal residents of the State of Texas who are 18 years of age or older at time of entry. Employees, officers, and directors of Sponsor, its parent, subsidiaries, affiliates, advertising and promotion agencies, prize suppliers (including GFT Rewards, Pop Vault, The Legend Blockchain), and the radio partner (Hot 107.3 Dallas), and each of their immediate family/household members are not eligible. Begins **September 12, 2025 at 6:00 AM Central Time (“CT”)** and ends **September 19, 2025 at 11:59 PM CT** (“Promotion Period”).

4. How to Enter

Limit one (1) entry per person per day during the promotion, regardless of method.

Multiple entries in a day by the same person, phone number, device, email, or household will be void.

(A) QR + SMS Entry:

During the Promotion Period, visit Hot 107.3's website, or partner websites, and scan the campaign QR code. Follow prompts to send the designated keyword by SMS to the short code/number provided. By texting, you agree to receive **one-time** sweepstakes confirmation and, if you separately consent, **recurring automated marketing messages** from Sponsor; **consent is not a condition of entry or purchase. Msg & data rates may apply.** Text **STOP** to cancel (requests will be honored within **10 days**); text **HELP** for help. Carriers are not liable for delayed or undelivered messages.

5. Rewards/Coins Clarification (Not Consideration)

Participants may receive promotional **Chili Coins (CHI)** in connection with on-air drops or SMS flows. CHI is a promotional reward; **no coin acquisition is required to enter or win** and coin possession or use **does not affect odds.**

6. Prizes & Approximate Retail Values ("ARV")
