*Furthermore, the whole paper should be written in approximately **3000-8000 words** in A4 paper size, including appendices, tables, and graphs. The margin should be set as follows: left 4 cm, right, top, and bottom 3 cm. Meanwhile, the paper title is written in Times New Roman 12 points, bold, center, all caps, and maximum 3 rows, and is followed by a blank row. The name(s) of the author(s), also, is written in Times New Roman 10 points, center, and bold, and between the authors' names, they are separated by a comma and followed by a number (superscript) to differentiate the authors' institutions. The author's institution is written in Times New Roman 10 points, center, and italic, and is followed by a blank row. Lastly, the correspondence e-mail is written in Times New Roman 10 points, center, and italic, and followed with a blank row with two-line spacing.*

INTRODUCTION

The paper should be written in justified paragraph, Times New Roman 12 points, 1.5 line spacing where the first line of each paragraph is indent 1.5 cm. The outline of the paper: ABSTRACT, INTRODUCTION, LITERATURE REVIEW, RESEARCH METHOD, FINDING AND DISCUSSION, CONCLUSION, ACKNOWLEDGEMENT (if any), BIBLIOGRAPHY, and APPENDIX (if any).

The paper should be addressed to OJS before deadline date. The citation in the paper is supposed to follow "author-year system", referring to the work in the bibliography. In the text, the cited work, also, is required to follow the rules as follow:

- a. A book or a journal citation from one and/or two author(s) should mention the last name(s) of the author(s) and the year of the book publication. For instance, Charles W Kreidler is written (Kreidler, 1998), Masrul Huda is written in (Huda, 2019), Faidah Yusuf and Reski Amelia are written (Yusuf & Amelia, 2018), and the cited page is unnecessary written in the citation.
- b. If the citation comes from the Journal whose author is more than two people, the citation should use terms 'et all'. For instance, Surnaningsih, Syahrani Junaid, nahdhiyah are written with (Surnaningsih et al., 2020),
- c. if the citation comes from more than two sources cited at the same time, the writer should follow the proposed form. For instance, Syahrani Junaid and Kustiwan Syarief are written in (Junaid, 2012; Syarief, 2013). Meanwhile, if two or more writings come from the same author, the writer should follow (Junaid, 2012; Syarief, 2013)
- d. if the cited sources come from more than one writing by the same author in the same year of publication, it is a must that the citation ends with a, b, and so forth after the year of citation. For instance, (Junaid, 1999a; Junaid, 1999b).
- e. A citation from the internet sources is written by mentioning the author and the year. If there is no author, the full website address should be completely written in detail.
