PWR Town Hall – Aug. 13

Our office is holding a virtual Town Hall on Wednesday, August 13 at 2:00pm to discuss significant changes coming to postsecondary and workforce readiness options for students. Learn about several policy and funding updates on what we're calling "The Big Three" outcomes (college credit, industry-recognized credentials, and quality work-based learning), which also includes accountability changes to the PWR sub-indicator on the performance framework.

PWR Regional Trainings

We will hold six regional trainings from September through December to support districts and schools in understanding the new PWR updates, including new funding information, "The Big Three" outcomes, and accountability changes to the PWR sub-indicator on the performance framework. A new ICAP Model will also be offered as an optional tool to implement The Big Three.

Registration will open three weeks prior to each training date with a waitlist enabled once capacity is reached. Priority will be given to regional districts and schools. While registration will not close, we ask that attendees register at least one week before the event date so we can arrange for any accommodations and dietary needs. Construction Training and Scholarship – Aug. 25

<u>Hands to the Future</u> is accepting applicants for their new Construction Connect cohort taking place the week of August 25. Participants must be at least 18 years old, have intermediate English skills, and hold a valid work permit.

The program will support participants with classes at New America College to improve English language skills if needed. Otherwise, participants will engage in

hands-on training from Teach by Tech to learn how to use power tools and earn certifications for working in the construction field.
