
Stages of US Foreign Policy

Marshall Plan

Essential Question: What was the idea behind the Marshall Plan and why was it it desperately needed?


<u>Truman Doctrine</u>

Activity: Support or refute the statement in an essay citing evidence for your opinion: The Truman Doctrine > Eisenhower Doctrine.




Brinkmanship



<u>Détente</u>

Essential Question: In the middle of the Cold War, why would Nixon want to scale back tensions with one of our ideological enemies?

Task: Read this biography of Henry Kissinger, the architect of the Policy of Detente. Discuss your feelings that Nixon's new cozy relationship with the Chinese was in reality aimed at the Soviets

Activity: Create a symbol that reflects the goal of Kissinger and Nixon's goal in detente **Bush Doctrine**

Essential Question: What are some potential problems and ethical challenges to the Bush Doctrine, both US and world points of view?

Task: Can a pre-emptive war be justified? Discuss this with a partner and come up with some examples
