1. Update on 2021/22 survey progress

Ireland	Finish Nov & submit data by end of Dec 22.	Online (Qualtrics) and paper (mainly 11 year olds)	
England	Completed with 37 schools, n=5600 with ~1400 removed after cleaning.	Online (Qualtrics) and paper	Plan to distribute reports when NR prepared.
Canada	Have had a lot of school closures, other surveys simultaneously in field and variation across Provinces so data collection will continue to March 23. Collecting from 80,000 YP with HBSC sample returned.	Online (Qualtrics) and paper (driven by poor internet in remote areas)	All schools to receive report provided minimum number reached (ethics specified minimum number of 30 per cell) otherwise District report. Designed by Youth Board. Focus groups with schools.
Scotland	Competed June 22 with 137 schools, n=4388. Recruitment made more difficult because of National HWB census. School level questionnaire returned from 61% of schools. ### 2. Sharing best practice

Ireland	Will contribute early practice experience of using online platform to the MDG.
England	Described issues with qualtrics (e.g. with survey duplication and Cantril ladder).  Produced a lesson plan linking to curriculum with input from Youth group which has helped with school engagement.
Canada	Described benefits of working with an experienced Qualtrics programmer to enhance online data collection.
Scotland	Relationship with local authorities was key to school recruitment. Developed a data dashboard as a class room resource and have been sharing with all schools.

Ireland	Planning for Autumn 23	Likely to be similar to 2018 with printed versions for schools & key stakeholders + soft launch but may possibly move to online only.

England	Spring 23	Printed versions mainly for schools. Met with funders recently to discuss content (including gambling and online gaming) and impact.
Canada	2023	Discussions to start shortly with HBSC youth advisory board who decide on the theme of the national report (may be around social media or gender). Also produce 'Mini reports' and every Province receives a report on an agreed template.
Scotland	Draft Spring 23	Main deliverables are the National report, School Level report, Pupil report and archiving in UK Data Service.
