Organization Description

The Come Follow Me Foundation is a 501(c)(3) non-profit focused on helping members of The Church of Jesus Christ of Latter-day Saints build a lasting habit of meaningful daily scripture study. We are a member-created and supported community.

The Come Follow Me App was the first tool launched by the Foundation in July of 2021. It has quickly become the leading 3rd-party application supporting members around the world. The app has over 400,000 users (growing at >100% YoY) and facilitates millions of scripture study sessions each month in both English and Spanish. The app has received ~30K user reviews with an average rating of 4.9 stars, and it consistently ranks in the top-100 apps on the Apple App Store.

The Foundation is now working on expanding its portfolio of tools and resources to help even more members. These include:

- Launching a Youth-focused app
- Launching a Missionary and Investigator-focused app
- Expanded language support for the Come Follow Me App
- Launching other non-mobile app capabilities (eg. Alexa, Apple TV, etc.)

Role Description and Qualifications

The Come Follow Me Foundation is looking to find an experienced lawyer who can advise the Foundation on a range of issues on a pro-bono basis. This is an exciting opportunity to play an important role helping an organization that is blessing the lives of hundreds of thousands of people around the world.

Areas where we will need legal support include:

1. Regulatory organization and filings
 - Helping to ensure we do everything necessary to stay in compliance with our 501(c)-3 public charity status
2. Board oversight

- Working with our board to ensure they meet their fiduciary responsibilities
- 3. IP / Trademark
 - Helping to ensure we have proper IP / Trademark protection in place
- 4. Licensing / partnership agreements
 - Helping to ensure we have appropriate agreements in place with our key partners

Candidate Qualifications

Requirements for this role include:

- Law school graduate
- Licensed to practice law in the United States
- A passion for helping members of The Church of Jesus Christ of Latter-day Saints improve their scripture study experience

This role can be done remotely and will allow for flexible hours. Over time we do not anticipate this requiring significant time (~5 hours per month), but initially we likely will need more support as we get certain things set up.
