Gender identity topic - Creekside Charter School will continue to educate parents on protocols.

CHYA - CALIFORNIA HEALTHY YOUTH ACT:

Provides the appropriate education to the pupils.

GOAL: Provide pupils with the knowledge and skills necessary to have healthy, safe, and positive relationships.

The CHYA materials are unbiased, age appropriate, and medically backed.

Gender orientation education is a part of CHYA and formal lessons occur in grades 5, 7, and 8th.

Sexual health instruction is in 5th grade and will support each of the required components of the CHYA. There will be a parent night prior to the

spring sex, health, and gender education and parents may opt their child out. However, if a parent opts out of this education, it is a decision to opt out of all elements, not just one.

The CHYA is a state level Act of education, not specific to Creekside Charter School curriculum.
