For all other titled vehicles, the odometer mileage reported during the vehicle's most recent transfer of ownership is printed on the front of its New York State Certificate of Title (MV-999). If the odometer had passed its maximum reading at the time of sale, the description "EXCEEDS MECHANICAL LIMITS" will be printed below the reported mileage. If the actual mileage is unknown because the odometer is broken, or has been repaired or replaced, the front of the title will be printed with "NOT ACTUAL MILEAGE, WARNING ODOMETER DISCREPANCY." The damage disclosure statement on the back of the title certificate must be completed regardless of the vehicle's age.

This form certifies the purchase price and determines the sales tax you must pay when registering the vehicle. If the form is not filled out by the seller, you will be charged sales tax based on the vehicle's current fair market value. TrueCar does not broker, sell, or lease motor vehicles. The dealer also may provide a temporary certificate of registration and, if needed, new license plates.
