## **Superintendent/Principal Report:**

Superintendent Hawley reported on the following items.

- Elementary Parent Teacher Conferences will be held March 12-13, we will have early release on 3/12 and no school on 3/13. This is the time parents and teachers can discuss the educational growth of their student.
- Winter Sports Report Wrestling is going well, last week's meet was canceled due to weather, we have a meet scheduled for this weekend. We currently have 20 boys out, no girls but the interest in the sport is growing. Girls basketball is going well also.
- Spring Track Schedule is in the packet, we will not be hosting a meet this year. We are looking for a coach.
- Battle of the Books This will begin soon, it is always a fun for the students. They will have 17 books that they will read and answer questions on. Jacob asked what grades participate. This is a K-5 event.

- Elementary Principal this would be a new position to add to the budget for the 2025-2026 school year. The high school currently has a full time principal and it would be beneficial to hire one for the elementary school as well. Discussion followed.
- Capital Projects for the new year were discussed. We are looking at and receiving bids for the kitchen upgrade and the roof at the high school. We will be posting an RFP in our local newspaper and on our website for the classroom expansion as discussed at the January meeting. Further discussion followed.
- Superintendent Evaluation Tool Mr. Hawley presented the board with a revised evaluation tool. A copy is in the packet. Discussion followed.
- Contract extensions Discussion was held. We will approve the selection in March.
- First Reading The school calendar for 2025-2026 was presented for a first reading, discussion was held. We will revisit this in March.

### Information Items:

- Budget Process We have given Budget Request forms out to all staff and are waiting to receive them back. We use these requests to prepare the budget. Discussion followed.
- Harney County Chamber Student of the Year 2025 Congratulations to Ross Clark for being nominated and winning the Crane Student of the Year for 2025! Ross was unable to attend the banquet due to a conflict with Basketball, but will be recognized in an assembly.
