A number of positions will be open for election in 2021 at the General Assembly. This document sets out the positions open for election.

This document contains three table lists in order to give a clear view of which positions are open to elections. The table lists contains the following stacks:

- A. **Position:** The position open for election (note that only positions open for elections are listed)
- B. **Incumbent:** The person currently holding the position, alternatively "vacant" when no-one is currently holding this position.
- C. **Eligible for re-election:** Informs about the status of the incumbent holder of a position. Following alternatives are used:
 - **No:** The incumbent holder can not run for re-election according to the statutes
 - **Not running:** The incumbent holder does not wish to run for re-election
 - **Yes:** The incumbent holder wishes to run for re-election
 - **Blank:** There is no incumbent holder
