NEENAH — Jarvis D. Stankey, 83, of Neenah, formerly of Oshkosh died Monday May 15, 1995 at Mercy Medical Center.

He was born Nov. 26, 1911 in Waushara County the son of Otto and Helena Fraker Stankey. Jarvis married Nora Neitzel in Oct. 1939 in Oshkosh and she preceded in death on Nov. 20, 1983. He then married Louise Lohman Dix on May 23, 1987 in Neenah.
